The BOD is considering the many aspects of the fountains and has not yet come to any conclusion on the fountain idea. Lot 1 asked; When u compare the prior ARC guidelines and the New, there seems to be somethings added and some deleted. The one deleted is about the playground equipment shielded from the street.
