At the annual meeting we voted to extend security another year. We will vote each year at the annual meeting so be there when you can. Also, an important piece of information: In Gwinnett County burglary has increased about 30% and robbery 47% since 2006. In our neighborhood these crimes have gone down 80%. Homeowners, please note that security in our neighborhood should not create a

You still need to lock your doors, turn on you security system, get pins for your windows, make sure you have two inch dead bolt locks, and keep your garage doors closed when you are not watching.

Trash Service

Gwinnett County is changing the rules on trash pickup. It is required for all homeowners and will be added to your tax bill each year. The new system will begin in January 2009 and be fully implemented by July 2009 to give companies and customers enough time to make changes. Residents will keep paying their trash haulers directly until they are notified about the selection of the waste hauler for their neighborhood. Some trash companies are offering a discount to those who pay for a full year of trash pick-up up front. I would not take this option, because the county wide trash requirement may overlap and you will lose your money. For more information you can go to www.gwinnettcb.org. Water Ban

The State of Georgia has declared a Level 4 Drought response for the northern third of the state, which prohibits most types of residential outdoor water use. Gwinnett County follows the State's regulations. We can water the lawn and flowers with a hose only on odd/even days for 25 minutes only. No sprinkler systems are allowed. Pumpkin Cake (preheat oven to 425 degrees)

1 Lg can pumpkin
11/2 cups sugar
1 tup evaporated milk
1 tsp salt
2 tsp cinnamon
2 tsp ginger

Mix together and pour into a well greased 13x9 pan. Sprinkle with 1 box of yellow cake mix (no pudding). Drizzle with $\frac{1}{2}$ cup of melted butter. Bake at 425 degrees for 15 min then 350 degrees for 45 min. If cake mix on top starts to burn, cover with foil.
