RE: FOLLOW UP INFORMATION RELATED TO THE BRIBERY OF MY TRIAL JUDGE AND, OBSTRUCTION OF JUSTICE AND RETALIATION TO BRING ABOUT A WRONGFUL CONVICTION; AND, OBSTRUCTION AND RETALIATION BY TDCJ PERSONNEL IN VIOLATION OF TEXAS PENAL CODE SECTIONS 36.04, 36.05, 36.06, 37.09, 37.10, 39.02 AND 39.04

DEAR LT. LINDEMANN,

ATTACHED IS ADDITIONAL DOCUMENTARY EVIDENCE IN SUPPORT OF MY ALLEGATIONS THAT:

1. IN ALL PROBABILITY MY TRIAL JUDGE, TRAVIS COUNTY 299TH DISTRICT COURT JUDGE KAREN SAGE WAS BRIBED FOR HER RULINGS, DECISIONS AND ORDERS IN CASE NO. DC-13-90421 TO BRING ABOUT WRONGFUL CONVICTIONS.
2. MY PROSECUTOR, ASSISTANT TRAVIS COUNTY DISTRICT ATTORNEY HOLLY TAYLOR, WAS OUT "FUNCTIONING AS AN INVESTIGATOR" INTERVIEWING WITNESSES, TAKING PHOTOGRAPHS AND GATHERING EVIDENCE WELL BEFORE THERE WAS ANY MEANINGFUL PROBABLE CAUSE, NULLIFYING HER ABSOLUTE (PROSECUTORIAL) IMMUNITY. FACTS NOT KNOWN UNTIL 1 OCTOBER 2014, 1 YEAR AFTER MY TRIAL.

3. TDL PERSONNEL JOHN D. SEIGLE, AMY E. OLIVER, WILLIAM ABBOTT, RAYMOND HERITAGE, PATRICIA TAYLOR, LAWRENCE NUNN, ASHLEY BUNCH, TAZOLYN AMERSON, MELISSA WILSON, THOMAS BOUGHNER, LONNIE BOSTICK, SERGIO PEREZ, DONALD BILNOSKI, ROBERT HERRERA, DAVID NICHOLS, "MG", JOHN LOPEZ, BRUCE TOMNEY, BRYAN COLLIER AND OTHERS CONTINUE TO RESTRAINT, DEPRIVE ME OF RIGHTS AND PRIVILEGES, INCLUDING MY RIGHT TO PRACTICE MY RELIGION, AND CRIMINALLY OBSTRUCT JUSTICE. ATTACHMENT 1 SUPPORTS ATTACHMENT 2 IN MY OCTOBER 5<sup>TH</sup> LETTER TO YOU.

4. PAGE 1-1 IS A COPY OF TWO PHOTOGRAPHS (FOR COLOR PRINTS GO TO COURT OF CRIMINAL APPEALS OF TEXAS DOCKET SITE, CASE NO. WR-82,475-03 OR LET ME KNOW AND I WILL HAVE COLOR PRINTS MADE FOR YOU) OF THE ELSTIK METER FOUND ON PAGES 2-8 AND 2-9. IN THESE PHOTOGRAPHS HOLLY TAYLOR'S REFLECTION IS VISIBLE IN THE METER GLASS AS SHE WAS TAKING PICTURES, NOT LOU CARTER AS THEY LED EVERYONE TO BELIEVE.

TAYLOR AND HER SUPERVISORS, SUSAN OSWALT AND GREG COX AND ROSEMARY LEHMBERG KNOWINGLY AND INTENTIONALLY WITHHELD THIS CRITICAL INFORMATION AND WERE ALSO INSTRUMENTAL IN THE MALICIOUS DESTRUCTION OF EXONERATING EVIDENCE BEFORE TRIAL.

5. PAGES 1-2 THRU 1-10 ARE COPIES OF COURT TRANSCRIPTS OF HOLLY TAYLOR'S TESTIMONY IN FEDERAL COURT ON 1 OCTOBER 2014.

HOLLY TAYLOR TESTIFIES THAT THEIR COMPLAINANT,

TRAVIS COUNTY DEPUTY TOBY MILLER, NEVER READ THE GRANT APPLICATION.

TRIAL RECORDS AND DOCUMENTARY EVIDENCE SHOW THAT TOBY MILLER GOT CAUGHT, BY ME, FALSIFYING GRANT TIMESHEETS, ATTEMPTING TO STEAL TRADE SECRETS, ILLEGALLY USED THE NUC FOR PERSONAL GAIN, BROKE IN TO JONESTOWN CITY HALL, FALSIFIED HIS COUNTY TIME SHEETS COMMITTED AND IS SUSPECT IN OTHER FELONIES AND INITIATED A RETALIATION SCHEME UNDER THE COLOR OF HIS AUTHORITY.

TAYLOR GOES ON TO ADMIT SHE WAS OUT FUNCTIONING AS AN INVESTIGATOR AND, SHE BUSTED THE AUSA, DAN GUESS, ON 12 BRADY VIOLATIONS THE FEDS COMMITTED TO SECURE ANOTHER WRONGFUL CONVICTION TO COVER UP THE FBI'S FAILED NATIONAL SECURITY THREAT INVESTIGATION INVOLVING MY RUSSIAN SPY IN THE HOUSTON SHIP CHANNEL.

TOBY MILLER IS A DIRTY COP. AT THE MOMENT, I WON'T GET INTO LOU CARTER, TAYLOR OR HER BOSSES. 6. THERE WERE MOTIONS FOR DISMISSAL, MISTRIAL, DIRECTED VERDICT AND MORE SAGE DENIED AFTER HEARING SUBSTANTIAL INFORMATION REGARDING PROSECUTORIAL MISCONDUCT. A COMPETENT JUDGE ADHERING TO THE CONSTITUTION AND LAWS SET FORTH BY THE SUPREME COURT AND TEXAS PENAL CODE WOULD HAVE STOPPED THE UNETHICAL, UNCONSTITUTIONAL AND ILLEGAL BEHAVIOR AND PREVENTED A MISFEASANCE OF JUSTICE.
