Course Description:

This **Non-Language Specific** Four (4) credit hour, **Non-Instructor Led Course**, will familiarize today's Interpreter with common terms and meanings associated with current **Human Trafficking Terminology** and Phrases. According to the California Department of Justice, Human trafficking is among the world's fastest growing criminal enterprises and is estimated to be a \$150 billion-a-year global industry. Due to this, we will ultimately see a rise in criminal cases that require Interpreters to be knowledgeable in terminology and phrases specific to human trafficking. Terminology such as **"in-pocket"**, **"Head Cut"**, **"Circuit"** and **"Renegade"** seem unassuming and non-threatening, but have a whole different meaning and effect when it comes to human trafficking. Through a combination of provided video resources, comprehensive self-guided terminology exploration, definition/word matching and photo/term matching and "True & False" questions, the language professional can expect to gain a better understanding of terminology and phrases commonly and not so commonly used in today's courtrooms. Due to the sheer volume of Human Trafficking information, this course will be an extended course (4hrs.) and will require the Interpreter to have the means to access the internet to research and discover the terminology contained within the Non-Instructor led class, This "self research" in turn, will allow the Interpreter to select the correct answer given in the course.
