6. Old Business

The new lease agreement discussion will be tabled until the next meeting because the Fire Company President is not present.

The Fire Company generator maintenance contract has expired. The new maintenance contract was signed and will be mailed to Atlantic Switch and Generator, a New Jersey based company. The new maintenance contract is approximately half of the previous maintenance contract and provides more services. The PO was signed and the package was sent to Atlantic Switch & Generator.

Thomas Bellone Sr. received a bill from Verizon Wireless for 7 network devices. Mykola "Nick" Myronowskyj looked into the matter as determined that it was for the fire company Ipad's and other network devices that are not specifically telephones.

A new application and the process for new fire company members was discussed. The Chief is in agreement with the new form and process. This new form will eliminate the old 3X5 cards and will include a background check authorization. This new form is being worked on and will be submitted for review ASAP.

The Board of Fire Commissioners, District 4 and the Fire Company will be researching a policy and program for zero tolerance for drugs and alcohol. This will also include a process and training of certain personnel for identification of potential "under the influence" and a medical method for determining that a member was actually "under the influence".

The Board of Fire Commissioners, District 4 and the Fire Company will be researching a policy and program for medical physical program for all Fire Company members.

7. New Business

State of New Jersey Board of Fire Commissioners Association renewal was discussed. After looking into the Association, is was determined that continued membership was of no benefit to the District, and we will be able to save the cost of the annual fee.

Ed Paul stated that a voucher must be attached to every bill that is submitted. Mykola Myronowskyj questioned the type of voucher that is needed. He will contact Ed Paul and get clarification from the accountant.

Dennis Allonardo has been reinstated as Chief of the Department. David Cella Jr. and Edward Conrow have resigned from the Fire Company.
