

Bloomfield Police Department

Monthly Report for April 2019

This is the monthly report for the Month of April 2019 from the Bloomfield Police Department. It is the police department's goal to keep the citizens of Bloomfield Township/Village informed as to the police department's activities, statistics, and community projects. It is very important that the citizens be aware of the various concerns that have and are occurring within our community.

On Monday, April 1st at approximately 8:44pm officers responded to a residence on Primrose Road for a disorderly conduct complaint. At the conclusion of the investigation charges of disorderly conduct have been referred to the Walworth County District Attorney's office for a 31-year-old female and a 32-year old male. An additional charge of substantial battery was referred for the female suspect.

On Friday, April 3rd at approximately 10:54pm officers attempted to initiate a traffic stop for a speeding violation. The vehicle began to flee by increasing the vehicle speed until the vehicle left the roadway at the intersection of Hafs Rd and N. Daisy where it crashed into several smaller trees and brush. At the conclusion of the investigation a 36-year-old male was arrested and confined in the Walworth County Jail. A charge of fleeing & eluding a traffic officer has been forwarded to the Walworth County District Attorney's office. Additionally, the suspect was arrested for operating a motor vehicle while intoxicated 1st offense and speeding.

On Sunday, April 7th at approximately 2:05am officers observed three subjects drinking beer while standing near the intersection of S. Lakeshore Drive and Thistle Road. At the conclusion of the investigation a 19-year-old male, a 20-year-old male, and a 20 year female were all issued non-traffic citations for underage possession/consumption of alcohol.

On Monday, April 8th at approximately 12:32am officers executed a traffic stop on Hwy 12 near Pell Lake Drive for an equipment violation. At the conclusion of the traffic stop a 27-year-old male was arrested for operating a motor vehicle while intoxicated 1st offense. Additionally, the male driver was issued a traffic citation for operating a motor vehicle without insurance.

On Wednesday, April 10th at approximately 1:13pm officers received a theft complaint from Liberty Mechanical located on Hwy 120. It was reported that person(s) unknown by unknown means removed a truck cap without the owner's consent. This incident remains under investigation.

On Thursday, April 11th at approximately 7:50pm officers responded to the area Laurel Rd and Hawthorne Rod for a vehicle versus pedestrian hit & run crash. At the conclusion of the investigation a charge of hit & run has been forwarded to the Walworth County District Attorney's office. There were not any injuries associated with this crash.

On Saturday, April 13th at approximately 10:38am officers responded to a residence on Eau Claire Rd. for a disorderly conduct complaint. At the conclusion of the investigation charges of disorderly conduct have been referred to the Walworth County District Attorney's office for a 31-year-old female, a 28-year-old male, and a 23-year-old female. An additional charge of criminal damage to property was referred for the 23-year-old suspect.

On Sunday, April 20th at approximately 11:45am officers responded to the area of Flamingo Road for a hit & run property damage only complaint. At the conclusion of the investigation a 34-year-old female subject was issued two traffic citations for vehicle owners liability for FSA.

On Sunday, April 28th at approximately 1:35am officers executed a traffic stop in the area of Nippersink Rd and Powers Lake Road for a speeding violation. At the conclusion of the traffic stop a 29-year-old male subject was arrested for operating a motor vehicle while intoxicated. Charges of operating a motor vehicle while intoxicated 2nd offense and operating after revocation have been forwarded to the Walworth County District Attorney's office.

On Tuesday, April 30th at approximately 6:17pm officers responded to a residence on Rose Drive for an assist to EMS request. At the conclusion of the investigation charges of possession of drug paraphernalia and child neglect have been forwarded to the Walworth County District Attorney's office.

During the month of April 2019, the Bloomfield Police Department responded to 787 calls for service compared to 897 calls for service during the month of April 2018. During the month of April 2019, the police department affected 123 arrests for various violations of Bloomfield Municipal Ordinances and Wisconsin State Statutes compared 156 arrests during the month of April 2018.
