Determine best mulch for project (Mela Leuca/Flora Mulch?) and obtain quotes to have delivered. Plan volunteer day to place mulch-Cheryl.
- 5. Daventry Fountain-broken. Outdoor Concepts (Todd)/Jacklyn will get quote.
- 6. Benches/Picnic tables-one of picnic tables will be moved to swing set area (Jacklyn/Dave). Benches and picnic tables have been repaired..thank you DAVE!
