- General petition received by the school board by 25 Stratton voters requesting the school board contact the Secretary of Education and request a formal and definitive


opinion on Stratton Tuition Payment Policy F16, Section 3C adopted on January 15, 2019. It was noted that there are additional signatures anticipated.
