## Five Year Strategic Plan Adopted

In January 2021 our hard-working long-term leader, Lynne Lewis, stepped down and Ray Ezell became President of the Orange County Historical Society. Soon afterwards, I made a motion to start a design and fundraising project, but that discussion soon bogged down. Instead, I suggested we do a Five-Year Plan to help us focus on our needs and their possible solutions.

To explore this further, Ray Ezell appointed Mike Saxton, Clara Colby, Bernice Walker, Frank Walker, and Joe Wayner to a committee with me serving as chair. We sought input from committee chairs, staff, and members. Twenty eight meetings later, we finished examination of our Vision and Mission Statements, and came up with a plan that addresses each of the society's objectives.

Hopping between rabbit holes, Mike Saxton did a Herculean job of helping us craft wording acceptable to the committee for each set of Goals and Actions. During the Holiday season Mike and I received input to a suggested Preamble and Executive Summary. We incorporated as many pertinent inputs as space allowed.

Please note: this plan is to be used as a guide only. It is not mandatory. It is a fluid document subject to change at any time by the Board of Directors.

The Plan was presented to the Board of Directors on January 18, 2022 and was unanimously adopted as our official Five Year Strategic Plan. Copies are available for anyone's perusal at the OCHS research center.

### Little Petersburg Cemetery Clean Up Project

This past November 6, volunteers gathered to work on the Little Petersburg Cemetery. After clearing away brush, vines and fallen limbs and collecting trash, they identified 13 headstones and found an additional 65 graves. Some may pre-date the Civil War.

The cemetery has been surveyed and the deed updated to reflect the current Bethel Baptist Church trustees. The cemetery is now thought to be secure for the foreseeable future.

### Mrs. B. Wood's: A Green Book Site in Orange County

*Editor's Note- Ann Miller, always on the lookout for some transportation-related history, sends the following:*

Between 1938 and 1967, *The Negro Traveler's Green Book* was a guidebook listing safe and welcoming venues for black travelers in that segregated era. Founded and originally published by New York City mailman Victor Hugo Green, this yearly publication provided information on establishments in the U.S. offering automotive service and transportation, lodging, food, entertainment, personal care, and other services.

Among the Virginia locations, one Orange County site was noted in the Green Book. But the exact location is uncertain: entries between 1950 and 1956 list lodging provided by "Mrs. B. Wood, R.F.D. 2, Orange, Virginia." Does anyone remember Mrs. Wood, her business and its location, or know if the building still stands? If you do, please contact the historical society at [info@orangecovahist.org](mailto:info@orangecovahist.org) We'd love to have more information on Mrs. Wood--and make sure that she has her place among Orange County entrepreneurs of the era.
