In consideration of the services of Kangaroo's their agents, owners, officers, affiliates, volunteers, participants, employees, franchisors, and all other persons or entities acting in any capacity on their behalf, I hereby agree to release, indemnify, and discharge Kangaroo's, on behalf of myself, my spouse, my children, my parents, my heirs, assigns, personal representative and estate as follows:

1. I acknowledge that my participation in Kangaroo's activities entails known and unanticipated risks that could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity.

The risks include, among other things: Kangaroo's Inflatables entail certain risks that simply cannot be eliminated without jeopardizing the essential qualities of the activity. Risks include the negligence of other participants or myself, injuries including rope burn, sprains, fractures, scrapes, bruises and cuts, dislocations, pinched fingers and serious injuries to the head, back, or neck which can cause paralysis, or even death. Inflatables expose its participants to the usual risk of cuts and bruises. Other more serious risks exist as well. Participants often fall off equipment, sprain or break wrists, ankles and legs, and can suffer more serious injuries as well. Traveling to and from Inflatable locations raises the possibility of any manner of transportation accidents. Participants often fall on each other resulting in broken bones and other serious injuries. Use of the inflatables can be dangerous and can cause serious risk and must be done at the participants own risk. In any event, if you or your child is injured, you or your child may require medical assistance, at your own expense. Furthermore, Kangaroo's employees have difficult jobs to perform. They seek safety, but they are not infallible. They might be unaware of a participant's health or abilities. They may give incomplete warnings or instructions, and the equipment being used might malfunction.

2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.

3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Kangaroo's from any and all claims, demands, or causes of action, which I may sustain while on the premises or are in any way connected with my participation in Kangaroo's activities or my use of Kangaroo's equipment or facilities including any such claims which allege negligent acts or omissions of Kangaroo's.

4. Should Kangaroo's or anyone acting on behalf of Kangaroo's, be required to incur attorney's fees and costs to enforce this agreement, including to defend or respond to any claim which I have waived or from which I have released Kangaroo's hereunder. I agree to indemnify and hold Kangaroo's harmless for all such fees and costs.

5. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have.

I hereby voluntarily waive my rights to a civil Liability lawsuit on Kangaroos in the State (Indiana) and/or Federal level against Kangaroo's eir agents, owners, officers, affiliates, volunteers, participants, employees, franchisors, and all other persons or entities acting in any capacity on their behalf. I agree that if any portion of this agreement is found to be void or unenforceable. the remianing portions shall remian in full force and effect.

**By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain, file, create a lawsuit against Kangaroo's on the basis of any claim from which I have released Kangaroo's herein. I have had sufficient opportunity to read this entire document. I have read and understood it, and I agree to be bound by its terms.**
