

# Bloomfield Police Department

## Monthly Report for July 2017

This is the monthly report for the Month of July 2017 from the Bloomfield Police Department. It is the police department's goal to keep the citizens of Bloomfield Township/Village informed as to the police department's activities, statistics, and community projects. It is very important that the citizens be aware of the various concerns that have and are occurring within our community.

On Saturday, July 1<sup>st</sup> at approximately 8:08am officers responded to a personal injury traffic crash on Hwy B at the Hwy U intersection. At the conclusion of the investigation a 49-year-old female was issued traffic citations for failure to obey stop sign and vehicle operator fail/wear seat belt.

On Sunday, July 2<sup>nd</sup> at approximately 2:29pm officers responded to a residence on Birchwood Road for a theft complaint. It was reported that person(s) unknown had taken a black 2016 mini bike from their residence without permission. This case remains an active investigation.

On Tuesday, July 4<sup>th</sup> at approximately 1:13am officers responded to a residence on Phlox Road for a report of an armed subject. At the conclusion of the investigation a 42-year-old male was arrested and confined in the Walworth County Jail. A charge of disorderly conduct has been forwarded to the Walworth County District Attorney's office.

On Thursday, July 6<sup>th</sup> at approximately 9:12pm officers responded to the parking lot of the Pell Lake Inn. for a report of a hit & run property damage only crash. At the conclusion of the investigation a 40-year-old male was issued traffic citations for hit & run - unattended motor vehicle and failure to notify police of an accident.

On Thursday, July 6<sup>th</sup> at approximately 9:59pm officers responded to the front of the Post Office for an operating a motor vehicle while intoxicated complaint. At the conclusion of the investigation a 62-year-old female was arrested for operating a motor vehicle while intoxicated 1<sup>st</sup> offense. Additionally the female was issued traffic citations for operating left of center and unsafe lane deviation.

On Sunday, July 16<sup>th</sup> at approximately 5:55am officers responded to a residence on Douglas Ave for a theft complaint. It was reported that person(s) unknown had a pontoon boat on a trailer from their residence sometime overnight without permission. This case remains an active investigation.

On Wednesday, July 19<sup>th</sup> at approximately 6:40am officers responded to a residence on Florence Road for a report of suspicious vehicles/activity. During the course of the investigation a 2013 Yamaha motorcycle was recovered which had been reported as stolen from a dealership in Woodstock, Illinois. The motorcycle and investigation have been turned over to the Woodstock Police Department.

On Sunday, July 23<sup>rd</sup> at approximately 4:32pm officers responded to a residence on Clover Road for damage to automobile complaint. It was reported that the rear passenger side window was broken out of complainant's vehicle.

On Thursday, July 27<sup>th</sup> at approximately 1:34am officers responded to a report of a portable washroom on fire near the intersection of N. Lakeshore Dr. and Lakeshore Drive adjacent the public beach. The fire was ultimately extinguished by the Bloomfield-Genoa City Fire Department. This case remains an active investigation.

On Saturday, July 29<sup>th</sup> at approximately 11:34am officers responded to a residence on Green Road for a disorderly male subject. At the conclusion of the investigation a 48-year-old male was arrested and confined in the Walworth County Jail. Charges of battery, disorderly conduct and criminal trespass to land have been forwarded to the Walworth County District Attorney's office.

During the month of July 2017 the police department effected 98 arrests for various violations of Bloomfield Municipal Ordinances and Wisconsin State Statutes compared to 85 arrests during the month of July 2016.
