# Rout Montréal

**Montréal, Québec**, incorporated as a city in 1832, population 1,704,694 (2016 c), 1,649,519 (2011 c). Montreal is Canada's second largest city and is home to nearly half of the province of Quebec's population. It is the metropolis of the province and was the most populous city in Canada for a century and a half. It is located in southwestern Quebec on Île de Montreal at the confluence of the St. Lawrence and Ottawa rivers. Montreal is a major industrial centre, commercial and financial metropolis, railway and maritime bridgehead, and one of the centres of francophone culture in North America. It is one of the world's great cities and enjoys international acclaim.

The present-day island of Montreal and the surrounding areas were long inhabited by the St. Lawrence Iroquoians. The island was a good site for settlement due to the natural resources nearby, and the St. Lawrence River and Lachine Rapids made it necessary for travelers to stop there and unload their boats. In 1535 French navigator Jacques Cartier visited one of their villages, Hochelaga, a large village made up of approximately 50 longhouses and a population of approximately 1,500 people located on the slopes of Mont Royal, a small mountain of volcanic origin. The residents of Hochelaga were primarily agriculturalists, but also ate fish and game. For reasons that remain unclear but may include European diseases and wars with other groups, the St. Lawrence Iroquoians disappeared as a distinct nation by the late 16th century.

Montreal (sometimes also called Ville-Marie) was founded in 1642 as a missionary colony under the direction of Paul de Chomedey de Maisonneuve and Jeanne Mance, but the fur trade soon became its main activity. Maisonneuve and his group of four dozen colonists were caught in a storm of conflict between Indigenous peoples for control of the fur supply. A permanent state of war with the Iroquois marked the early decades of the colony's existence (see also Iroquois Wars). In 1665, Louis XIV sent 1,200 French troops to the colony, and these troops attacked the Iroquois the following year. Permanent peace was only established in 1701 with the conclusion of a major treaty, La Grande Paix, between the French, the Iroquois and more than 30 other Indigenous groups.

Montreal was a city of the interior, in contrast to Quebec City, which was the administrative capital and the main port where exchanges with France took place. Montreal soon became the great centre of the fur trade. Coureurs de bois, voyageurs and such famous explorers as René-Robert Cavelier de La Salle, Daniel Dulhut, Pierre Le Moyne d'Iberville and Pierre Gaultier de La Vérendry all set out from the city. These traders and explorers methodically explored the North American continent from the Gulf of Mexico to the Rockies and established a network of trading posts to secure furs for the Montreal fur trade. The fur trade relied on the labour of Indigenous peoples and did not provide much employment in Montreal itself.

Strong dependence on this single industry and the region's weak agricultural output resulted in slow population growth early on. At the end of the 17th century, for example, the city had just over 1,000 inhabitants. Almost one century later, in 1789, the population had only reached approximately 5,500.

The goal of the GDN is a global, equitable, accessible and sustainable Digital Learner Data Portability environment. Among the largest global issues to this end we list a fundamental lack and imbalance of global data and digital capacity, and the need for sustainability as advocated in UNESCO's Sustainable Development Goals. The GDN 2020 destination, India, is singularly well placed to elicit your interest, as some major initiatives are currently underway such as the Digital India Initiative and the 5-I vision, both aiming at maximizing the benefits of digital technologies for social benefits to the Indian population.

From its start, the Groningen Declaration Network had a long-standing interest in anything to do with the development of India's digital service provision, especially since the establishment of the Indian National Academic Depository (NAD) initiative and, more recently, DigiLocker, a paperless, authentic governance serving as India's citizen wallet and thereby providing the kind of infrastructure that could make the GDN aims and vision come true.

For its 9th Annual meeting, the GDN aims at convening practitioners and supporters to continuously share digitalization development and use cases, strategies and tactics that are working, at expanding the number of new projects moving forward globally where capacity is lacking, and at bringing new ideas as technologies and methods evolve to the forefront to help achieve the goal.

Within PESC, the Data Privacy and Protection Task Force, formed one year ago at the Fall 2018 Data Summit in San Francisco to serve as an open forum in which data and datarelated topics affected by data privacy laws are discussed. One focus of the Task Force included considerations for the development and maintenance of PESC Approved Standards that would be recommended to PESC for adoption in data exchange standards. Recent discussions within the Task Force have focused on understanding what information or direction do institutions need to communicate to third-party data processors (such as the National Student Clearinghouse) and SIS providers about data that is subject to the EU GDPR and California Consumer Privacy Act and any restrictions on its use or processing. The Task Force proposed a solution for adoption but is now reflecting on the solution and pausing to gather more intelligence, continue educating one another and expand its perspective to include the secondary perspective (K12). Panelists will discuss the challenges of addressing data privacy laws and regulations that carry different requirements, provide an overview of similarities and differences between these laws and share survey information about how some institutions are approaching their compliance obligations. The panel will also administer a real-time survey and facilitate discussion among the attendees of this session so compliance approaches by institutions that work with SIS providers and the Clearinghouse can be discussed.

The new Europass is a set of web-based tools and information to support individuals in managing the different stages of their career and learning. These tools and information will be made available on a new online platform that is being developed by the European Commission. The platform will introduce a new specification for digitally-signed credentials, known as the EDCI (European Digital Credential Infrastructure), as well as providing the issuing and storage features typical of digital credentials and ePortfolio systems. The new Europass development is a decision of the European Parliament and the Council of European Union, and is part of the Digital Education Action Plan (Action 3). The new platform is currently being tested by 15 members states with the support of domain experts and is expected to be launched publicly in February 2020. The session will provide an overview of the different component of this new Europass platform.

Partnering together to ensure a consistent, strategic direction is vital and these speakers will discuss the value of collaboration and its value proposition inherent in each initiative. Operating under AACRAO and governed by a Steering Committee, the Learner Record Matching Index (LRMI) is a new initiative to help maximize and operationalize record matching, thereby reducing costs and duplication. Operating under PESC and governed by a Steering Committee, GEO Code is a free, open and standardized directory of codes and identifiers for institutions and education organizations. Operating under PESC and governed by a Steering Committee, EdExchange is a neutral data exchange platform and digital look-up service, Application Platform as a Service (aPaaS or PaaS), designed as a peer-to-peer network providing a secure, reliable, trusted and direct connection between users avoiding file-based technologies.

#### The Secret Transfer Guides: How BCCAT is Collaborating to Reveal Hidden **Educational Pathways beyond British Columbia**

Dr. Rob Fleming, Executive Director & Co-Chair, BCCAT

While many provinces have developed provincial transfer guides, the data that's publicly available for individual provinces is often limited in comparison to the data for transfers from out-of-province or outside Canada that is held within internal transfer credit tables in a student information system such as Banner or Colleague. This data often remains hidden from the public, and transfer students only learn about their transfer credit assignments after admission. As a result, academic advisors at colleges have limited resources to advise transfer students from out-of-province or abroad for course planning.

In 2018/19, the BC Council on Admissions & Transfer (BCCAT) partnered with the University of British Columbia (UBC) in a pilot to import UBC's internal transfer credit



tables, and adopt BCCAT's Transfer Credit System (TCS) as the workflow for all articulation activities at UBC's Okanagan and Vancouver campuses, including inter-provincial and international equivalencies. The result saw the import and publication of over 50,000 equivalencies from over 600 institutions at 43 countries, making the data publicly available for the first time on UBC's websites for both campuses. The data from UBC's transfer credit tables can now be leveraged by transfer students and other members of BC's transfer system. This pilot is serving as a model for an ambitious expansion of the BC transfer system, which includes an additional pilot to integrate the TCS with Banner.

This presentation will provide the story on this pilot project from the perspective of BCCAT, including the challenges, processes, lessons learned, and the next steps moving forward on this exciting initiative.

The Council of Ministers of Education, Canada (CMEC) through the coordination efforts of the Canadian Information Centre for International Credentials (CICIC) is leading several projects to support digitization and international credential assessment to meet Canada's obligations under the Lisbon Recognition Convention, which was ratified by government in 2018. As one example, a CICIC representative is supporting the DigiREC project which aims to systematically explore the connection between digitization of student data and the fair and smooth recognition of foreign credentials. CMEC is also working with the teaching regulatory bodies across Canada to develop capacities for assessing internationally educated teachers across a range of projects of relevance to this space. Examples include creating the capacity for language proficiency testing, developing competency and credential mapping frameworks, and enhancing the resources and tools in Canada to support credential assessment. Joanne Duklas and her team at Duklas Cornerstone Consulting are supporting their efforts with developing assessment resources and tools for 12 comparator countries which is important early work to support future infrastructure development and support of digitized document assessment. She will share information regarding the work of CICIC, CMEC and provide an update on the project.



## **OVERVIEW**

The Canadian presence and influence within PESC has existed since the very formation of PESC. As Canadian students cross provincial and international borders to attain their education, the need for institutions, software providers and systems vendors that support Canadian and international markets to ensure mobility and interoperability has never been greater.

The formation of CanPESC in 2011 solidified the importance of Canada's role within PESC and drew together many Canadians from across the country to work towards a common goal. Its main mission is twofold:

- To serve as a clearinghouse for discussion and new ideas, a coordinator to help support electronic initiatives with several liaison roles established, and as a unifier in the mission toward digitalization of educational records.
- To focus on interoperability, enhanced service and delivery, reduced cost, and improved data quality using PESC Approved Standards. CanPESC communicates these benefits for Canada's students, institutions and Canadian-based educational stakeholders by raising awareness of the importance of standardization and interoperability.

As the voice and official committee representing Canadian interests, CanPESC has participation throughout almost every province and territory in Canada from provincial application centres, leading universities and colleges, and service providers.

## **BENEFITS**

True benefits of interoperability are enhanced service and delivery, reduced cost, and improved data quality. CanPESC ensures these benefits for Canada's students and institutions by:

- Raising awareness of the importance of standardization and interoperability
- Promoting PESC standards nationally in order to achieve global interoperability
- ➤ Participating in other PESC User Groups to remain informed of ongoing initiatives and how they affect Canadian interests
- Ensuring that PESC standards represent Canadian interests and usage
- Coordinating communications and sharing ideas across provinces and territories
- > Actively encouraging and supporting interprovincial partnerships
- Ensuring a direct Canadian voice and solid representation in global initiatives as a result of its relationships with PESC and ARUCC, both of which are Groningen Declaration Network signatories

## **HISTORY**

The Canadian influence and perspective has been a major part of PESC since its founding and continues to be.

- ➤ In PESC's 1<sup>st</sup> Annual Best Practices Competition in 1999, the Ontario Universities' Application Centre (OUAC) won 1<sup>st</sup> PLACE for its submission, "Ontario Universities' Electronic Transcript System (OUETS): A Model of an Electronic Standardization Initiative."
- ➤ In PESC's 14<sup>th</sup> Annual Best Practices Competition in 2012, the Ontario College Application Service (OCAS) won 1<sup>st</sup> PLACE for its submission, "OCAS XML Transcript Initiative."
- For PESC's 10<sup>th</sup> Anniversary Year, the Fall 2007 Data Summit was held at the Ritz-Carlton Hotel in Montreal.
- At the Fall 2011 Data Summit held October 26, 2011 in San Francisco, PESC launched the Canadian PESC User Group.
- For PESC's 15<sup>th</sup> Anniversary Year, the Fall 2012 Data Summit was held at the Four Seasons Hotel in Vancouver.
- ➤ Through establishment of CanPESC, PESC began discussions with ARUCC and in 2013, entered into a formal MOU with ARUCC, allowing ARUCC and PESC to attend each other's events without charge, thereby fostering a closer working relationship.
- ➤ OUAC staff have been recognized with PESC's Distinguished Service Award: Doug Holmes in 2013 and Leisa Wellsman in 2016.
- > OCAS' William McKee served on the PESC Board of Directors from 2013-2015.

The first deliverable of the Canadian PESC User Group was to introduce PESC at the ARUCC Conference June 25-28, 2012 in Ottawa. PESC staff exhibited at ARUCC and several sessions were held on data standards and interoperability. Soon after, PESC and ARUCC formed a partnership, and in signing a joint Memorandum of Understanding (MOU), combined forces to network across each other's organizations and to raise the level of awareness regarding standards, mobility and interoperability within the profession of higher education administration and management. Representatives of ARUCC also joined the Canadian PESC User Group.

## **GOVERNANCE**

CanPESC is a permanent group within PESC, ultimately governed by the PESC Board of Directors. CanPESC encourages active participation and diverse membership across Canada. It is semi-autonomous, reporting directly to the PESC Board of Directors, and is responsible for its overall activities, communications, meetings, and outreach.

CanPESC Co-Chairs are from PESC Member organizations and appointed by the PESC Board of Directors.

CanPESC meets via web and teleconference monthly on the 2<sup>nd</sup> Thursday at noon EST (9 am PST, 5 pm Greenwich); and at PESC Spring and Fall Data Summits (combined in-person and web/teleconference); and communications are supported by a PESC list.

## **AVAILABILITY & COST**

CanPESC is a transparent and collaborative committee open to all Canadian stakeholders free of charge.

## **ROLE**

- Educate Canadian stakeholders while promoting the importance of data standards and interoperability, thereby avoiding duplication of effort and of data standards.
- Promote PESC at Members' individual organizations and within their sectors to raise awareness of PESC Approved Standards and how they support, enhance and simplify inter-system operability, performance and data access.
- Ensure Canadian-based stakeholder interests are represented in PESC.
- Serve as a PESC Approved Standards and implementation leader and resource group to all Canadian postsecondary education sector stakeholders.
- Develop projects that will enhance the experience of students, universities, colleges, administrators and government by enabling effective data exchange across Canada in the postsecondary education sector.
- Encourage participation in PESC Groups developing PESC Approved Standards
- Participate in digital data standards and student national mobility initiatives as invited by ARUCC and other leading education organizations
- Develop and provide presentations on CanPESC initiatives

## **CURRENT STATUS**

At this time, CanPESC is participating and cooperating in several initiatives through ARUCC and through PESC:

- ➤ Continuation of the work started by the ARUCC Groningen and Student Mobility Task Force The ARUCC Groningen and Student Mobility Task Force was formed in 2014 to focus on advancing student mobility through data exchange. CanPESC members contributed to this work, which led directly to ARUCC's signing onto the Groningen Declaration Network as Canada's first signatory. Following the signing, the task force's last undertaking was to distribute a national survey, the results of which signaled widespread support for pursuing next steps toward a pan-Canadian transcript exchange network. That work is now underway, and CanPESC and PCCAT will provide expertise and insight to ARUCC during the research phase of this initiative.
- The ARUCC-PCCAT Transcript and Transfer Guide was launched in early 2016. CanPESC served as electronic data exchange advisors in the creation of this national, online tool. CanPESC has a seat on the ARUCC-PCCAT Transcript and Transfer Guide Working Group.
- ➤ National survey CanPESC recently conducted a national survey of post-secondary institutions, application centres, and provincial ministries of education and advanced education. The goal of the survey was to obtain details on the code sets respondents use to identify high school and postsecondary institutions within their systems, which is crucial to successful national transcript exchange.
- ▶ PESC Fall 2019 Data Summit In recognition of the influence and inspiration Canadian education has had throughout the world and prominently within PESC since its foundation, PESC returns to Montreal for the Fall 2019 Data Summit October 22 25, 2019. CanPESC Members serve as the program committee and CanPESC meets in a pre-Summit, day-long meeting host by McGill University on Tuesday October 22, 2019.
