It has been a pleasure to serve RCA for the last three years, and I look forward to a final year of formal service as Immediate Past President when the presidential gavel is passed to Robert Woods in Chicago this November. As I reflect on my time in office, I am struck by the enduring commitment to service that RCA engages, from the members who submit and evaluate papers, attend sessions, and vote on policies to the councilors and officers who offer the energy of leadership to chart a course for RCA's future.

This service is recognized with gratitude and thanks, fitting tribute to service rendered from the heart, and is accompanied by (and I believe I speak for officers past and present) the knowledge that one has given one's time and energy to a worthy institution. Moving out of formal leadership is a continued call to

service in other ways; the service does not stop. This history of commitment to service is one of RCA's greatest strengths, a strength recognized by its members over the years and one that I pray will continue over the course of RCA's upcoming future. - May RCA remain committed to excellent scholarship. Our journal, the *Journal of Communication and Religion*, has continued to provide a significant outlet for research productivity for many; our scholarship is being read more widely, its readership increases yearly, and its articles are in demand. Continued collaboration with scholarly data bases such as EBSCO will ensure positioning of our journal prominently within the reach of scholars nationally and internationally.

One way to continue a focus on scholarship is to initiate a series of conferences, perhaps

(Continued from page 1) every other year, with invited scholars and contributed papers culminating in an edited publication, funds from which would revert to RCA. Hosting such conferences at universities and colleges with commitments to religious traditions or to religious scholarship would provide excellent access to RCA's work and recognition for host institutions.

Another way is to continue to publicize our scholarly awards, a process begun this year. Recognition for the work of RCA award winners benefits RCA, awardees' host institutions, and the larger scholarly community.

Continued connection with NCA seems important; this year witnesses additional co-sponsored panels with NCA divisions. While we have increasing points of contact with NCA, remaining independent and affiliated balances multiple goods.

Finally, preconference activities

can continue to serve membership well; without the need to plan a yearly conference, energy can be devoted to preconference activities with an eye to potential connections to biennial conferences.

- May RCA remain committed to students. Through mentoring, providing opportunities for presentation and publication, and modeling a commitment to scholarship, teaching, and service, RCA can provide encouragement and support to the next generation of scholars and leaders in the area of religious communication in the academy and marketplace—and provide secure leadership continuity for RCA.
- May RCA remain committed to service. RCA will remain as strong as its service commitment. The offices taken on by leadership are service positions, taken on by teacher/scholars with other commitments; they are engaged as contributions to the

organization, to the academy, and to faith traditions grounded in servant leadership. Gratitude and knowledge of work well done reward such service.

I offer thanks to Robert Woods, Vice President, with whom it continues to be a pleasure and joy to work; Ken Danielson, Executive Secretary, whose knowledge of and commitment to RCA know no bounds and whose wisdom and sense of humor have sustained us for so long; to Calvin Troup, Immediate Past President, for his outstanding leadership over these last years; to Rodney Reynolds, 2nd VP, for his willingness to take on leadership and for heartfelt care for RCA; to John Pauley for his careful and diligent editorship of *JCR*; to Dann Brown for keeping everyone informed of RCA events and happenings with exceptionally high-quality newsletters; to Michael E. Eidenmuller for his won-

derful work as web master; to councilors Matt Althouse, G. L. Forward, and Mark Williams for their support and assistance in so many ways, and to all award evaluators, paper and panel readers, paper and panel contributors, and RCA members for countless contributions through service and participation that keep RCA thriving!
