◆ Run at Cottonwood Equestrian Center. ◆ Must run both days to qualify for average awards.

◆ Open to everyone, no nonmember fees. **EACH RACE BRN4D TRIPLE POINTS** (must be a member and pay \$2 per entry).

(1D=fastest time, 2D+.5 second, 3D+1 second, 4D+1.5 seconds, 5D+2 seconds)

◆ **\$1000 PESI OPEN BONUS** (\$500 each day, must enter Open, must belong to WPRA and horse[s] PESI enrolled).

◆ **\$250 added Saturday \$250 added Sunday WPRA Sidepot** (roll times from 5D) ◆ **Open WPRA co-approved both days**

◆ Riders may not switch their horses' positions. Horses must be run as they appear in the draw.

◆ Dress code: Cowboy hat, long-sleeved shirt, western pants and boots are required attire.

◆ A knocked down barrel results in a no-time (however, in the WPRA/PESI sidepots there is a 5-second penalty for each knocked down barrel).

◆ UBRC Top Guns, Ledge Guns (50 & over) and Young Guns (18 & under) sidepots Saturday and Sunday, roll from Open
