Subject: Lowering Defense Costs and Initiating Acquisition Reforms

Dear Sen. Warren:

I watched the nomination hearing for Deputy Secretary of Defense Hicks. You asked the right question: "Do you believe that we can find way to lower the top-line budget number and then spend that money more effectively without sacrificing our security?"

As you often say, "I have a plan for that!"

My detailed plan also addresses related issues that have been raised by your current colleagues and predecessors:

- Rep. Henry Waxman
- HASC Chair Ike Skelton
- Sen. John McCain
- Sen. Kamala Harris
- HASC Chair Adam Smith
- Sen. Ernst
- Sen. Sanders
- Sen. Tester
- Rep. Norcross

In the past, I supported Chairmen Skelton and McCain in drafting NDAA provisions which became law and in oversight activities. I also submitted recommendations to the other senators and representatives above as well as Pres. Elect Trump. Some of my recommendations to DOD were incorporated into acquisition policy and guides.

Now I seek your help to complete acquisition reforms regarding Program/Project Management (P/PM) and a management tool used within P/PM called earned value management (EVM). My plan will not only address your question to Ms. Hicks but will also cover the following issues:

- Unjustified Award Fees
- Contractors "manage data" in order to "make the number"
- Contractors "keep Earned Value Management (EVM) metrics favorable and problems hidden."

- Replace NDIA-owned EVM standard EIA-748 with ANSI-accredited Project Management Institute Program/Project Management (P/PM) standard and PMBOK® Guide
- Fraud, waste, and abuse
- Status quo is barrier to entry to potential contractors not in the military/industrial complex

The following table includes some of my letters, articles, and tutorials since 2004. Unfortunately, the only NDAA provisions that were passed were only seminal and did not yet result in effective reforms. I believe that the NDIA has consistently obstructed meaningful reform, including Chairman Smith's P/PM provision in the last NDAA. Since there is a lot to read, I recommend starting with the items that are highlighted.

- Providing earlier detection and reporting of Nunn-McCurdy breaches and higher Estimates at Completion (EAC). Enable earlier termination of "rathole" (per Chairman Smith) programs to curtail needless spending
- Program managers manage development and testing of the *product* instead of "managing the numbers," wasting time on analyzing Management Reserve (MR)
