



## 2020 THOMET STABLES HUNTER/JUMPER SERIES

May 30, July 25, Aug 29 8:30 a.m. Rain or Shine

### DIVISIONS

**GREEN:** Horses in their first or second year of showing. Jumps set at 2'

**OPEN:** Open to all horses and riders. Jumps set at 2'6" - 2'9".

**LIMIT:** Open to non-professional riders. Jumps set at 2'5".

**LOW HUNTER:** Open to non-professional riders. Jumps set at 2'3".

**PONY:** Open to non-professional riders with ponies 14.2HH and under. Jumps set at 2'.

**NOVICE:** Open to non-professional riders in their **first or second year of showing over fences, OR that haven't jumped higher than 2'3"** at any horse show. Jumps set at 2'.

**CROSSRAIL:** Open to non-professional riders who are in their **first or second year of showing over fences, AND who have not jumped higher than 2'** at any horse show. You may trot or canter the crossrails. Flat classes are walk, trot, canter.

**WALK/TROT:** Open to non-professional riders who are in their **first year of showing** and/or who are not comfortable yet riding at a canter. To be shown at walk and trot only. Ground pole class will be trot only.

### INFORMATION

**\*\*All riders must have a signed entry form in the show office before schooling in any ring.**

**Entry Fee:** \$12 per class plus \$5 back number deposit, which will be refunded when back number is returned.

**NEGATIVE COGGINS** required for all horses entering the property.

**Stalls:** \$40 for Friday night and Saturday; \$25 for Saturday only. Stalls will be reserved with payment. First bedding provided. Stalls are limited.

**Attire:** This is a schooling show. Full attire is not required. Breeches, boots and a riding shirt are recommended. Helmet is required. Half-chaps are acceptable.

**Schooling:** Permitted Fri. 2-8:00 pm and Saturday dawn-8AM. Ring closes at 8AM sharp Saturday to be watered and dragged. **NO SCHOOLING WITHOUT A SIGNED LIABILITY WAIVER.**

**Awards:** First place prize and ribbons awarded through sixth place. All leadliners will receive a prize. Management reserves the right to divide, cancel or combine classes. High Point Champion and Reserve ribbon for each division. In the event of a tie, the Eq. O/F class will be the tie breaker. Divisions without an Eq. Class will use the Hunter O/F as the tie breaker.

**Professionals** allowed in green horse and open classes only. "Professional" refers to anyone acting in an instructional position or accepting payment for training.

**All judge's decisions are final.** Judge will be asked to not place anyone using a martingale or other head-setting device in flat classes. Hunter pace will be emphasized over number of strides in over-fences classes. Extreme speed will be penalized. Boots and other special equipment/tack are only permitted at judge's discretion.

**Trainers/parents** are responsible for making sure riders are entered in the correct classes for their abilities.

**Thomet Stables,** its management, employees and/or other horse show officials will not be held responsible for any accidents, damage or loss.
