The mission of the Keystone program is to provide residential treatment services in the arena of substance abuse and co-occurring disorders that are effective and medically safe for the individual in need of treatment. We also educate the person on the nature of substance abuse and mental health problems and how their life is affected by such problems. ACTS assists the individual in the recovery process so they can regain self-sufficiency.

## **Keystone Residential Treatment Program**

The Keystone Residential Treatment Program is a co-occurring adult level II, non-secure residential program for individuals, male and female, chronically debilitated from alcoholism or drug abuse and mental health issues, who have not responded to traditional treatment services. Keystone serves as an alternative to incarceration for both the Pinellas, Hillsborough, Pasco and Polk County jails.

### **Program Philosophy**

- To serve individuals with mental health and substance abuse disorders in a high quality program designed and professionally staffed to meet the needs of the individual and their families.
- To recognize and be fully aware that mental health and substance abuse problems vary in intensity, duration, effects, and other dimensions.
- To improve the general functioning in all dimensions of their life.
- To educate and encourage individuals to accept that substance abuse and co-occurring disorders can be successfully treated.

## Admissions Criteria

- 18+ years of age, males/females
- Homeless with co-occurring disorders
- Volunteer or court ordered
- Meet ASAM Level III.5 criteria
- Meet DCF Level 2 Residential criteria

## Exclusionary Criteria

- Individuals with special needs that are incapable of safely participating in treatment and intervention activities
- Persons determined to be beyond the safe management capability of the program due to severe medical or behavioral issues
- Persons under the age of 18 years
- Individuals with a history of sexual inappropriate behavior or previous sex offender allegations, charges, or convictions
- Persons with repeated violent offenses in previous treatment settings
- Individuals exhibiting active psychosis, suicidal / homicidal ideations
- Persons with outstanding arrest warrants



## Program Services

- Treatment services are customized, with different types and intensities of treatment approaches, according to the specific needs, strengths, abilities, and preferences of the individual.
- Medical staff completes a psychiatric evaluation, provides psychotropic medications when necessary as well as ongoing medication management and follow-up visits.
- Qualified staff monitors residents' medication self-administration.
- Nursing staff respond to physical health and well-being needs and make appropriate referrals when needed.
- Licensed Clinical Therapists and Certified Addiction Professionals provide individual, group, family and spirituality therapy sessions throughout the treatment stay.
- Educational groups are provided daily to address health and safety, recreation, living skills, finances, relationships, decision-making skills, nutrition, etc.
- The Seeking Safety Manual is utilized to deal with trauma issues during gender specific weekly groups.
- Random urine screenings are collected during the entire treatment episode.
- A Case Manager Specialist assesses each resident for comprehensive wrap-around services, helps with state and federal entitlements and facilitates connection with other community providers.
- Competency Restoration Training is provided to forensic clients found incompetent to proceed.
- All employees are trained in crisis intervention.
- Transportation Services are available for medical appointments, court appearances, and other ancillary services within the community.
- Residents attend daily 12 step meetings in the community and/or on site.
- The program offers room, board, and 24/7 supervision.
