SCHOLARSHIP CRITERIA AND ELIGIBILITY

Scholarship

RETEA will award two Scholarships in the amount of \$500.00 each for each school year, as stipulated in the Bylaw Policy 7.

CRITERIA & ELIGIBILITY

- 1. To be awarded to the son, daughter, grandchild (if the member is the legal guardian), stepchild or a child of legal guardianship of a member in good standing with the Association, who meets the following guidelines:
 - a) Must apply in writing to the RETEA Scholarship Committee
 - b) Continue his/her education at a recognized post-secondary institution
- 2. The money is to be held in trust by the Association until such time as the recipient(s) provides proof of registration at a recognized post-secondary institution of his/her choice.
- 3. The applicant will be required to submit his/her grade 12 marks as registered on his/her Permanent Report Card.
- 4. Applicant is to verify that he/she is the son, daughter, grandchild (if the member is the legal guardian), stepchild or a child of legal guardianship of an active member in good standing with RETEA.
- 5. The applicant must be enrolled as a full time (attending 60% or more) student in the academic year in which the application is being made.
- 6. An executive member of RETEA will make the presentation of the Scholarship to the student.
- 7. If, in any one year, only one application is received, then only one Scholarship shall be awarded to that one applicant (if eligible and meets the criteria). (The remaining monies will be held over in trust for following years.)
- 8. The applicant must provide two letters of reference, (one from an activity/volunteer coordinator; one from an employer)

Deadline for applications will be midnight of **May 15** of the present school year. The selection of the recipients by the RETEA Scholarship Committee will be made by **May 30** of the present school year. Notification of the Scholarship will be made by **June 15** of the present school year.
