Friday's ride left around 8:30 AM for the coast. We followed the road to Lorane and then west through twisty roads in the coastal hills of the

Siuslaw National Forest and along the Smith and Umpqua Rivers to Reedsport. Then south on Highway 101 to the Umpqua Lighthouse State Park. On the return trip, we followed Highway 38, with stops at the elk viewing stations and in Elkton for pie and/or ice cream at *Arlene's*. Another 35

Saturday morning started with an OTCsponsored pancake breakfast at the air museum. Cassie had a radio spot which helped swell the public attending the breakfast and to see our antique bikes staged for the ride. Saturday's ride featured travels past covered bridges and up into the gold mining country. The ride started southeast out of Cottage Grove, past four covered bridges and around Dorena Lake. Many riders stopped at Wildwood Falls for a break, and there was some swimming for relief from the heat. Then we went south about ten miles on a scenic tree lined road, continuing though the Umpqua National Forest. Some riders braved a two-mile side excursion on a gravel road to explore the area near the Mineral Creek Campground and Bohemia mine. The main route wound about 20 miles westerly along paved BLM roads - twisty and narrow, with grand views and steep terrain. A left turn at a tee took riders along a road paralleling the Big River for nine miles. Then right for 15 miles around Cottage Grove Lake and into the west side of Cottage Grove and past two more covered bridges.

D.C.'s Lone Girl Motorcyclist Stormed Loudly to Get Permit

Sally Robinson - She Weighs Only 88 Pounds - Had to 'Buffalo' Stalwart Policeman but Finally Won His Praise - and License.

By dint of stamping her foot Sally Robinson, of 2120 H Street Northwest, has become the only girl in Washington licensed to ride a motorcycle.

Miss Robinson—all 88 pounds of her—has been operating motorcycles on and off since 1928, but last spring she decided she wanted a permit. The policeman assigned to officiate at her examination had different ideas, however. Although the District has no law against women motorcyclists, this examiner apparently thought it should have.

"First he said I was too little, then he said I was too young," Miss Robinson declaimed yesterday, malice toward all policeman shining in her eyes." She is 27, years old and 4 feet 11 inches tall, and didn't see what either factor had to do with her sitting behind the handlebars of a motorcycle.

"I passed the written examination all right—passed it twice, in fact. The first time I got 80 on it, but that wasn't good enough for him so I went down again and got 92, when that didn't satisfy him, I got my lawyer.

"Well, that cop looked from me to the lawyer, and from the lawyer to me, and then he said I could take my road test," she continued. Her difficulties had not ended, however. Thinking all was well, she said goodbye to her lawyer and started out for the road test.

Then the policeman announced he would not ride with her in the sidecar of the machine he provided for the test —he said he was afraid to.



But when the test was over, the examiner announced, "Lady, you handle it as well as a man could. Your balance is swell and you know the machine. But I didn't see you kick it over so I can't give you the permit."

That was when Miss Robinson started "cussing him out."

"I called him such names - well, I was ashamed of myself. But it worked, and I have the permit."

Miss Robinson uses the smallest type of machine built, but at that it weighs 325 pounds, nearly four times as much as she does. Despite the fact, it occasionally falls on her, she insists she would rather ride that machine than eat when she's hungry. As for automobiles, she has no use for them whatsoever.

At present her chief goal is membership in the Capitolians, a newly formed motorcycle club of which Lynn Cook, 1515 U Street Northwest is president. She will be the only girl in the club, which does not share the Police Department's prejudice against the sex."

September 15, 1937. "First of fair sex to obtain motorcycle license in Capital. Although she weighs only 88 pounds -- one-third of the machine she rides, Mrs. Sally Halterman is the first woman to be granted a license to operate a motorcycle in the District of Columbia. She is 27 years old and 4 feet, 11 inches tall. Immediately after receiving her permit, Mrs. Halterman was initiated into the D.C. Motorcycle Club -- the only girl ever to be accorded this honor."

Article I: Name

The name of this regional chapter shall be the Oregon Trail Chapter of the Antique Motorcycle Club of America, Inc.

Article II: Purpose

The purpose of this club is to promote the preservation and restoration of antique, post antique and special interest motorcycles and to abide by and conform to the rules, regulations and bylaws of the Antique Motorcycle Club of America. Inc.

Article III: Elections, Board of Directors, and Officers

The Board of Directors will consist of the elected club officers. A President, Vice President, Secretary, Treasurer, and Activities Coordinator. The officers will be elected by majority vote of the membership attending the scheduled June meeting with installation taking place at the scheduled September meeting. The length of the term is one year for all elected positions; however, consecutive terms may be served. Representation for all Oregon Trail Chapter suggestions, comments or grievances to the Antique Motorcycle Club of America, Inc., will be limited to the elected chapter officers. The elected President shall have the option of selecting any replacement officer if a vacancy exists.

Article IV: Duties of Elected Officers

- (1) President:
 - (A) Conduct orderly meetings.
 - (B) Make committee assignments as necessary.
 - (1) Standing committees:
 - (a) Membership.
 - (b) Road runs- Road Run chairman shall report to membership all plans and approximate expenses prior to official public notification.
 - (c) Newsletter editor.
 - (d) Ensure that the official business of the club is attended to.
- (2) Vice President:
 - (a) Assume the responsibilities of the President if the President is not available.
- (3) Secretary:
 - (a) Record minutes of the official meetings
 - (b) Conduct all official correspondence.
- (4) Treasurer:
 - (a) Keep accurate record of all financial transactions in separate register.
 - (b) Pay all current expenses as directed by the membership.
 - (c) Any expense over \$200.00 shall be proposed at one scheduled meeting and voted on at the next scheduled meeting.

(5) Activities Coordinator

- (a) Work with other club officers to develop an annual event calendar, including monthly meetings.
- (b) Help identify activities and a member to host the monthly meetings. Activities may include garage crawls, museum visits, rides, and other activities of interest to the membership. Provide guidance to the member hosting a monthly meeting. This may include meals, ride planning, and other logistics.
- (b) Assist in coordination of activities for annual rally.

Article V: Membership

All Oregon Trail Chapter members are required to be members in good standing of the Antique

Proposed changes to bylaws are shown in red.

Motorcycle club of America, Inc. National membership numbers must appear on chapter application forms. No dues or assessments will be required of a member's spouse. However, they are entitled to full participation in chapter meetings and activities. Only one membership card and one copy of the newsletter will be sent. Voting privileges will be limited to dues paying members and their spouses only. Charter members of the Oregon Trail Chapter of the Antique Motorcycle club of America, Inc., are those members who joined the AMCA and the Oregon Trail Chapter prior to submission of the Oregon Trail Chapter's application to the National AMCA.

Article VI: Finances

The Oregon Trail Chapter will be operated as a non-profit organization. Annual dues will be used to finance the successful operation of the club. No direct attempt will be made to acquire a surplus of funds. Any treasury deficit may be corrected at any regular meeting by the most appropriate method. Club funds are to be entrusted to and accounted for by the elected club treasurer. Club funds will be carried in a checking account at an established banking institution. Funds may be drawn from the account for approved purposes by the club Treasurer or President. Financial reports must be filed on or before January 15th of each year.

Article VII: Club Publication

A newsletter or similar paper will be published quarterly or as needed monthly, to inform members of upcoming events. It will be sent to all the current Chapter members, all National AMCA Board Members and exchanged with interested AMCA Chapters.

Article VIII: Meetings

Regular monthly meetings will be held at the times and places announced in the newsletter. The newsletter will announce meeting information for the two meetings following its distribution.

Article IX: Amendments

Proposed amendments to these by-laws may be made at the regular scheduled February, May, and October Chapter meetings at the suggestion of any member in good standing, as long as the proposed amendment is consistent with National policy. Proposed changes to the bylaws must be made in writing. Proposals may be adopted by a single majority vote of the members present; however, no proposed amendment may be floored and voted on at the same meeting. The proposal must be floored at one meeting and voted on at the next meeting.

Article X: Dissolution of Club

In the event of club disbanding, all bills shall be paid, and remaining monies in the treasury shall be dispensed evenly with Oregon Trail Chapter members who have at least 2 full years of continuous membership.
