19 Peter S. Davis, as the court appointed Receiver, respectfully petitions the Court as
20 follows:

- 21 1. On August 18, 2016, this Court entered its *Order Appointing Receiver*, which
appointed Peter S. Davis as Receiver of DenSco Investment Corporation (“Receivership
Order”).

1 2. Pursuant to this Court’s *Order Re: Petition No. 1*, the Court approved the
2 Receiver’s compensation at the rate of \$250.00 per hour together with all reasonable costs
3 and expenses incurred relating to these services as Receiver. These services are billed by and
4 paid to the Receiver’s firm, Simon Consulting, LLC.

5 3. Pursuant to the *Order Re: Petition No. 1*, the Receiver has engaged the services
6 of the law firm of Guttilla Murphy Anderson, P.C., of Phoenix, Arizona, and the Receiver has
7 agreed to pay the law firm compensation at agreed hourly rates for the services of the firm
8 together with all reasonable costs and expenses incurred on behalf of the Receiver.

9 4. Pursuant to this Court’s *Order Re: Petition No. 10*, the Receiver has engaged
10 the services of the law firm of Frazer Ryan Goldberg & Arnold, LLP of Phoenix, Arizona
11 and the Receiver has agreed to pay the law firm compensation at agreed hourly rates for the
12 service of the firm together with all reasonable costs and expenses incurred on behalf of the
13 Receiver.

14 5. Pursuant to this Court’s *Order Re: Petition No. 2*, the Receiver is authorized to
15 file this fee petition without including as exhibits the itemization of services rendered to, and
16 costs incurred or expended on behalf of, the Receivership, provided that the fee petition
17 includes a statement that anyone desiring additional information concerning the services and
18 costs to be paid under the fee petition may obtain redacted information from the Receiver by
19 delivering to the Receiver and the Receiver's counsel, Guttilla Murphy Anderson, P.C., a
20 written request specifying the additional information requested at least three (3) days prior to
21 the date set for any hearing on the fee petition. The *Order Re: Petition No. 2* further provides

1 that upon request of the Court, the Receiver shall make available for in camera review by the
2 Court the itemized statements and supporting documentation for the services and costs to be
3 paid under the fee petition. Pursuant to the Court’s Minute Entry dated June 3, 2021, the
4 Receiver has submitted the itemized statements for “In Camera” review.

5 6. The Receiver has submitted an itemized statement for services rendered to this
6 Receivership by the Receiver and his firm, Simon Consulting, LLC, and for reimbursable
7 costs incurred or paid during the period of December 1, 2021 through December 31, 2021.
8 The total amount requested for payment by the Receiver is \$6,552.00. The Receiver believes
9 that this amount is reasonable and should be paid from the Receivership Assets.

10 7. The law firm of Guttilla Murphy Anderson, P.C., has submitted an itemized
11 statement for services rendered to this Receivership and for reimbursable costs incurred or
12 paid during the period from December 1, 2021 through December 31, 2021. The total
13 amount requested for payment by the law firm of Guttilla Murphy Anderson, P.C. is
14 \$3,728.75. The Receiver believes that this amount is reasonable and should be paid from the
15 Receivership Assets and has therefore approved this statement for payment.

16 8. The law firm of Frazer Ryan Goldberg & Arnold, LLP, has submitted an
17 itemized statement for services rendered to this Receivership by Marcum, LLP. Marcum,
18 LLP are accountants and advisors who assisted the law firm of Frazer Ryan Goldberg and
19 Arnold, LLP with tax consulting and professional services in connection with the DenSco
20 Investment Corporation through November 30, 2021. The total amount requested for
21 payment by the law firm of Frazer Ryan Goldberg & Arnold, LLP is \$1,975.03. The

1 Receiver believes that this amount is reasonable and should be paid from the Receivership
2 Assets and has therefore approved this statement for payment.

3 WHEREFORE, the Receiver respectfully requests that the Court enter an order
4 authorizing the Receiver to pay from Receivership Assets:

5 1. The amount of \$6,552.00 to Simon Consulting, LLC, for services rendered and
6 costs incurred or paid during the period December 1, 2021 through December 31, 2021;

7 2. The amount of \$3,728.75 to Guttilla Murphy Anderson, P.C., for services
8 rendered and costs incurred or paid during the period December 1, 2021 through December
9 31, 2021; and

10 3. The amount of \$1,975.03 to Frazer Ryan Goldberg & Arnold, LLP for expenses
11 incurred or paid to Marcum, LLP for the period ending November 30, 2021.
