Salute to the Flag: Regular meeting call to order:

Public Participation:

- Robert Yingling residing at 4951 Portage Street, Lilly, PA Washington Township requested a setback variance for his property, for the construction of pole barn.
- Setbacks are 25 (twenty five) from front, 10 (ten) feet from side to side and 10 (ten) feet from the rear of the property line, when served with sanitary sewer and potable water.
- Portage Street is a state road.

Motion made by Scott Guzic 2nd Raymond Guzic, Jr., to approve a setback variance for Robert Yingling, 4951 Portage Street, Lilly, PA, Washington Township, from 25 (twenty five) feet from the white line on Portage Street (Route 53 highway edge, closest to his property) to 17 (seventeen) feet, for the purposes of the construction of a pole barn, variance approved subject to compliance with the PA Department of Transportation requirements if any are applicable.
