

**AN ORDINANCE PROPOSING TO INCREASE THE AD VALOREM TAX LEVY FOR GENERAL FUND PURPOSES FROM THIRTY-THREE CENTS (\$0.33) TO FIFTY-CENTS (\$0.50) PER ONE HUNDRED DOLLARS (\$100.00) ASSESSED VALUATION ON REAL AND TANGIBLE PERSONAL PROPERTY WITHIN THE VILLAGE OF CLAYCOMO, AND PROVIDING FOR SUBMISSION OF THIS ORDINANCE TO THE QUALIFIED VOTERS OF SAID VILLAGE FOR THEIR APPROVAL AT THE GENERAL ELECTION CALLED AND TO BE HELD IN SAID VILLAGE ON TUESDAY, APRIL 3, 2018.**

**WHEREAS**, under the provisions of Sections 80.460 RSMo, it shall be the duty of such board of trustees to establish by ordinance the annual rates of tax levy for the year for municipal purposes upon all subjects and objects of taxation within such town,

**WHEREAS**, Section 80.460 RSMo, establishes the tax rate levy ceiling, which the tax shall not exceed the maximum rate for general municipal purposes of fifty cents on the one hundred dollars assessed valuation;

**WHEREAS**, the board of trustees of any such towns may submit a question for increase of levy when in the opinion of such board of trustees the necessity therefor arises,

**WHEREAS**, under the provisions of Section 80.460 RSMo, no ordinance enacted pursuant to the authority granted by the provisions of said Sections shall be effective until it has been submitted to the qualified voters of the Village and approved by a majority of the qualified voters voting thereon,

**NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF CLAYCOMO, CLAY COUNTY, MISSOURI**

**SECTION 1.** Pursuant to the authority granted by and subject to the provisions of Section 80.460 RSMo, the Board of Trustees proposes hereinafter to set out to authorize a seventeen cents (\$0.17) increase in the tax levy for municipal operating purposes from thirty-three cents (\$0.33) to fifty cents (\$0.50) per one hundred dollars (\$100.00) assessed valuation on real and tangible personal property within the Village of Claycomo.

**SECTION 2.** This ordinance shall be submitted to the qualified voters of the Village of Claycomo, Missouri, for their approval, as required by the provisions of Section 80.460 RSMo, at the General election hereby called and to be held in said Village on Tuesday, April 3, 2018. The ballot title will be:

**“SHALL THERE BE A \$0.17 CENT INCREASE IN LEVY ON ONE HUNDRED DOLLARS (\$100.00) ASSESSED VALUATION FOR GENERAL MUNICIPAL PURPOSES?”**

- YES (For the Proposition)**
- NO (Against the Proposition)**

The voter who desires to vote in favor of said ordinance shall fill in the oval opposite the word "YES" (or in the case of the use of voting machines shall pull the lever so as to place a cross mark (X) in such square opposite such word). The voter who desires to vote against said ordinance shall fill in the oval opposite the word "NO" (or in the case of voting machines shall pull the lever so as to place a cross mark (X) in the square opposite said word).

If a majority of the qualified voters voting at said election shall vote in favor of the approval of this ordinance, then the same shall be binding and in full force and effect.

**SECTION 3.** This ordinance shall take effect and be in full force from and after December 26, 2017

Read first in its entirety and second reading by title only this 26<sup>th</sup> day of December, 2017.
