## TRYOUTS AND TEAM PLACEMENTS

TRYOUTS AND TEAM PLACEMENT SESSIONS ARE ESSENTIALLY LOW-STRESS WORKOUTS. DURING THE WORKOUTS, ATHLETES SHOW SKILLS THEY HAVE ALREADY DEVELOPED AND DEMONSTRATE POTENTIAL TO LEARN NEW SKILLS. ATHLETES ARE GIVEN NUMEROUS OPPORTUNITIES TO SHOW SKILLS OVER MULTIPLE DAYS IF REQUIRED. MOST ATHLETES COMPLETE TRYOUTS IN ONE DAY.

AFTER THE TRYOUT SESSION OF PLACEMENTS, THE STAFF ASSEMBLES ROSTERS FOR THE UPCOMING SEASON. TEAMS ARE SELECTED SO THAT EACH HAVE THE BEST POSSIBLE CHANCE OF A SUCCESSFUL COMPETITIVE SEASON. AFTER ROSTERS ARE SET, ATHLETES WILL RECEIVE AN EMAIL LETTING THEM KNOW IF THEY MADE A TEAM AND IF SO BE INVITED TO TEAM REVEALS AT THE GYM.

WE OFFER MULTIPLE EVALUATION SESSIONS. WE STRONGLY PREFER ATHLETES ATTEND BOTH DAYS OF THE TRYOUTS. IF YOU WISH TO BE CONSIDERED FOR A FLYER POSITION ON A TEAM, YOU NEED TO ADDITIONALLY ATTEND ONE OF THE FLYER TRYOUTS.

## PRACTICES / ATTENDANCE

ALL TEAMS WILL HAVE A SET TWO DAYS A WEEK SCHEDULE. BOTH PRACTICES WILL BE HELD DURING THE WEEK. ADDITIONAL PRACTICES MAY BE SCHEDULED AT THE COACHES DISCRETION. PRACTICE TIMES USUALLY REMAIN CONSISTENT THROUGHOUT THE SEASON AND ARE ONLY CHANGED UNDER SPECIAL CIRCUMSTANCES. PRACTICES ARE MANDATORY FOR ALL ATHLETES.

ALL ATHLETES ARE REQUIRED TO TAKE AT LEAST ONE TUMBLING CLASS PER WEEK. IF THEY DO NOT HAVE PERFECT TECHNIQUE FOR THE LEVEL OF TUMBLING REQUIRED, THEY MAY BE REQUIRED TO ATTEND TWO TUMBLING CLASSES PER WEEK.

FLYERS ARE REQUIRED TO BE IN AT LEAST ONE STRETCHING CLASS PER WEEK. FLYERS ARE ALSO REQUIRED TO SEND IN BODY POSITIONS TWO TO THREE TIMES A WEEK TO THEIR COACHES. COACHES WILL NOTIFY THE FLYERS OF THE EXACT REQUIREMENT FOR FLYERS ONCE THEY ARE ON A TEAM.

ATTENDANCE IS MANDATORY TO ALL PRACTICES AND CLASSES, IF ATHLETES CANNOT MAKE A PRACTICE DUE TO ILLNESS PLEASE NOTIFY THE TEAM REP AND FILL OUT AN ABSENCE FORM.

THE ONLY AUTHORIZED REASON TO MISS A PRACTICE IS IF ATHLETE IS VOMITING OR HAS A FEVER. IF ATHLETES HAVE A COLD OR DO NOT FEEL WELL, ATHLETES MUST ATTEND PRACTICE AND WATCH FROM THE SIDELINE.

THE PROGRESS OUR ATHLETES SEE IN POSITIVE AND PRODUCTIVE SURROUNDINGS CAN BE AMAZING. A PAT ON THE BACK, A HIGH FIVE, AND POSITIVE REINFORCEMENT CAN GO A LONG WAY.

## COST / TUITION

COMPETITIVE CHEER, WHILE NOT AS COSTLY AS SOME YOUTH ACTIVITIES, CAN STILL BE EXPENSIVE. BEFORE CONSIDERING THIS OR ANY PROGRAM, PLEASE CONSIDER THE FINANCIAL COMMITMENT INVOLVED. INFINITE ATHLETICS HAS THE FINEST STAFF AND THE MOST STATE-OF-THE-ART FACILITY IN OUR SPORT. AS A RESULT, OUR FEES ARE SLIGHTLY HIGHER THAN A FEW LOCAL PROGRAMS. HOWEVER, FACTORING ENTRY FEES, SUMMER ACTIVITIES, FUNDRAISING, AND OTHER EXPENSES THAT ARE TYPICALLY CHARGED SEPARATELY AT MANY OTHER GYMS, YOU MAY END UP SPENDING MORE AT SOME OTHER PROGRAMS. ALTHOUGH OTHERS MAY ADVERTISE LOWER RATES, INFINITE'S OVERALL VALUE PER DOLLAR IS HIGHLY COMPETITIVE WHEN YOU WANT TO TRAIN WITH THE BEST.

WE HAVE A COMPREHENSIVE MONTHLY PRICE THAT COVERS MOST OF THE EXPENSES THROUGHOUT THE YEAR. DURING THE 2020-2021 SEASON, THERE WILL BE 12 MONTHLY CHARGES BEGINNING JUNE 1, 2020 THROUGH MAY 1, 2021. THE FIRST MONTHS TUITION WILL BE CHARGED ON MONDAY, JUNE 1, 2020. FOR THE REMAINING MONTHS, TUITION IS PAYABLE ON THE 1ST OF EACH MONTH.

THIS MONTHLY FEE COVERS TUITION AND MOST OTHER EXPENSES AND DOES NOT FLUCTUATE FROM MONTH-TO-MONTH. TUITION DOES NOT CHANGE BASED ON NUMBER OF PRACTICES IN ANY PARTICULAR MONTH.

THE VAST MAJORITY OF ATHLETES ATTENDING EVALUATIONS WILL BE SELECTED FOR A TEAM. IF INFINITE IS NOT ABLE TO FIND A PLACEMENT FOR AN ATHLETE, 100% OF THE TRYOUT FEE WILL BE CREDITED BACK. IF AN ATHLETE CHOOSES TO DECLINE A ROSTER SPOT PRIOR TO JUNE 7, THE INITIAL TUITION MONTH WILL BE CREDITED BACK AT 75%.

## MONTHLY TUITION

INFINITES ALL INCLUSIVE MONTHLY TUITION IS \$380 PER MONTH. PAYMENTS ARE DUE ON THE 1ST DAY OF EACH MONTH AND CONSIDERED LATE AFTER THE 5TH OF THE MOHNT. TUITION CAN BE PAID ONLINE WITH A CREDIT/ATM CARD. OR AT THE FRONT DESK.

## MANDATORY GYM FUNDRAISING

DURING THE SEASON INFINITE HAS 2 MANDATORY FUNDRAISERS:

1. FIREWORKS FUNDRAISER - EACH ATHELTE MUST SELL \$200 IN FIREWORKS PRESELL TICKETS. (JULY 2020)
2. CRAB FEED - EACH ATHLETE MUST SELL A MINIMUM OF 4 CRAB FEED TICKETS (MARCH OR APRIL 2021)

IF THE ATHELTES CHOOSES NOT TO PARTICPATE IN THE MANDATORY FUNDRAISERS THERE IS A \$250 BUYOUT FEE. BUY OUT FEES MUST BE PAID IN ADVNACE OF ELECTING TO NOT PARTICIPATE IN THESE ABOVE FUNDRAISERS.

CHEERLEADING AND GYMNASTICS EXPOSE PARTICIPANTS TO THE USUAL RISK OF CUTS AND BRUISES, AND OTHER MORE SERIOUS RISKS AS WELL. ## TUMBLING TECHNIQUE POLICY

TUMBLING TECHNIQUE NEEDS TO BE A TOP PRIORITY FOR EVERY SINGLE ATHLETE, PARENT AND COACH. TECHNIQUE SCORES SET APART THE TOP RANKING TEAMS FROM THEIR LESSER COMPETITORS. OUR FOCUS IS ON SKILL PERFECTION PRIOR TO PROGRESSING TO THE NEXT LEVEL. ATTAINING SKILLS THROUGH THIS NEW APPROACH WILL ENABLE OUR ATHLETES TO ACHIEVE THEIR GOALS IN A HEALTHY AND POSITIVE MANNER. PROPER TECHNIQUE WILL HELP MINIMIZE THE CHANCE OF AN ATHLETE SUSTAINING AN INJURY. REINFORCING SKILL PROGRESSION EVEN THOUGH ATHLETES STILL NEED CORRECTIONS IN ELEMENTARY SKILLS IS DETRIMENTAL TO THEIR TRAINING. THE MOST COMMON.

EXAMPLES OF SKILL IMPERFECTIONS INCLUDE:

- WEAK/BENT ARMS IN WALKOVERS
- BENT LEGS IN WALKOVERS
- ARCHED BACKS IN HANDSTANDS AND BACK HANDSPRINGS
- HEAD OUT AND LEGS APART OR BENT IN BACK HANDSPRINGS
- DROPPED SHOULDERS AND HEADS OUT IN BACK TUCKS

ALL OF THESE HABITS ARE KEY POINTS THAT NEED TO BE CORRECTED TO SUCCESSFULLY PERFORM A TUMBLING SKILL THAT IS READY TO MOVE ON TO THE NEXT LEVEL. ALTERING TECHNIQUE CAN BE A SCARY CHANGE FOR SOME ATHLETES. OFTEN WHEN MAKING THESE CORRECTIONS, SUCCESS DOES NOT HAPPEN RIGHT AWAY. FAILURE MAY OCCUR ON A SKILL THAT AN ATHLETE HAS PERFORMED FOR YEARS, BUT THIS SHOULD NOT DETER THE ATHLETE FROM MAKING THE ADJUSTMENT. A TUMBLING PORTFOLIO WILL BE KEPT ON EACH ATHLETE ON WHAT SKILLS THEY WILL BE ALLOWED TO WORK ON IN CLASSES, PRIVATES, AND TEAM PRACTICES. AN ATHLETE MUST BE SIGNED OFF IN SEVERAL LEVEL APPROPRIATE SKILLS IN ORDER TO MOVE FORWARD IN TUMBLING. TECHNIQUE IS A LARGE PART OF EACH TUMBLING CATEGORY, I.E., LEGS TOGETHER, LEGS STRAIGHT, HEAD POSITIONING, NO ARCH IN BACK. THIS WILL BE ENFORCED AND MONITORED REGULARLY. THE SAFETY AND SUCCESS OF YOUR ATHLETE IS A PRIORITY TO THE INFINITE STAFF.
