Rhoda Goldstein (Orange Lane) stated she has been a resident of the Village for forty (40) years and recently had to deal with some neighbors leaving their property unsightly as well as throwing late night parties with stages. She said she has nothing but praise for Code Enforcement Marisol Torrens and her efforts to keep the Village cleaned up.
