I want to keep this newsletter short and focused. As the 2023-2024 biennium comes to an end and the 2025-2026 biennium begins, I am challenging you with a call to action. Specifically, please consider doing two things:

First, I am asking you to write an old-fashioned snail-mail letter to the governor, send him an email, AND leave a voicemail for him. In each of these communications I would encourage you to encourage him to appoint more members to the Board of Opticianry so that it is comprised of what is supposed to be: five opticians and two lay people.

For a long time, the Board has only had four members (three opticians and one lay person) instead of seven. That means if only three of them show up for a meeting that makes a quorum. I don't think it is healthy or in the best interest of right and wrong to have an environment in which three people (or even four) can make decisions and craft rules that affect 3,900 opticians, 1,400 apprentices, and most importantly, 22 million Floridians. With seven members discussing issues and cases, common sense\_and reason will usually win out. With only three or four...who knows?
