ORDINANCE NO. <u>2008</u>-8

AN ORDINANCE OF THE VILLAGE OF CHAP!N, MORGAN COUNTY, ILLINOIS, AUTHORIZING THE SALE OF A 1983 FORD E SERIES VAN OWNED BY THE VILLAGE OF CHAPIN, ILLINOIS

WHEREAS, during a regular meeting of the Corporate Authorities of the Village of Chapin, Illinois, held on September 10, 2008, the Corporate Authorities concluded that it is no longer necessary or useful to or for the best interests of the Village of Chapin, Illinois, to retain ownership of the following personal property: a 1983 Ford E Series Van, Serial # A87967; and

WHEREAS, during a regular meeting of the Corporate Authorities of the Village of Chapin, Illinois, held on September 10, 2008, the Corporate Authorities determined that it was in the best interests of the Village of Chapin to sell said motor vehicle to the Triopia Youth Football Association for the sum of Five Hundred Dollars and 00/100 Cents (\$500.00).

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHAPIN, MORGAN COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: Pursuant to Section 11-76-4 of the Illinois Municipal Code (65 ILCS 5/11-76-4), the President and Board of Trustees find that the 1983 Ford E Series Van, Serial # A87967, now owned by the Village of Chapin, is no longer necessary or useful to the Village and the best interests of the Village will be served by its sale.

SECTION 2: Pursuant to Section 11-76-4 of the Illinois Municipal Code (65 ILCS 5/11-76-4), the Village President is hereby directed to take all necessary action to sell the 1983 Ford E Series Van to the Triopia Youth Football Association for the sum of Five Hundred Dollars and 00/100 Cents (\$500.00) and to transfer title and ownership to the vehicle to the Triopia Youth Football Association.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage and approval in the manner provided by law.
