- Rolling Meadows is a **Restricted Income** development. Income limits and rental rates are based on the TOTAL earnings of all persons in the household. Please refer to the Income Limit and Rental Rate tables based on the size of home you wish to rent.
- There are a limited number of homes in each price range. Income Limits and Rental Rates are subject to change in accordance with the State income guidelines, utility allowances and Area Median Incomes. These changes CAN be made during the lease term and may result in rental rates being increased or decreased. There are homes at “market rate” which means there are no income restrictions, but there are also no rent restrictions.
- **APPLICATION:** A \$25.00 NON-refundable processing fee is charged for each adult resident. This fee is applied toward a Credit Report and a Criminal Background Check. All payments are required to be made via online payment through the tenant portal.
- **DEPOSITS:** A \$500 Refundable deposit and a completed tax credit rental application is required to hold any apartment. Deposits will be refunded if the application is not accepted. All payments are required to be made via online payment through the tenant portal. We will send you the link to pay the deposit after you submit your short on-line form and pay the processing fee above.

- **RENT PAYMENTS:** Rent is due on the 1<sup>st</sup> and considered late on the 6<sup>th</sup> of each month. All payments are required to be made via online payment through the tenant portal or using the convenient pay-slip.
- **PETS:** A \$150 NON-Refundable fee (per pet) and a \$35 Monthly fee. There is a 25lb weight limit. All Deposits and Fees are waived for ESA or Service animals.
- **UTILITIES:** Resident is responsible for water, sewer, electric, cable and telephone. Trash services are paid for by the property.
- **APPLIANCES:** Each home is equipped with a refrigerator, dishwasher, range, microwave, Full Size washer and Dryer connections
