Open-Loop Geothermal Endorsement required for Pump Installers

Anyone installing or servicing a pump in an open-loop geothermal well must have a Pump Installer's Open-Loop Endorsement in addition to their Pump Installer's license. Any Master or Journeyman Pump Installer may obtain the endorsement from the Maine Water Well Commission by taking a short 20 question exam.

Two Commissioner's Terms are Expiring

The terms of two Commissioner's on the Maine Water Well Commission have expired and are up for reappointment by the Governor.

Ed Bowie, a water well driller member of the Commission, will continue to serve on the Commission until either he or a replacement is appointed by the Governor. Ed informed the other Commissioner's at their February meeting that he has not yet decided if he will ask the Governor to reappoint him or not. However, he wanted to make sure that other driller's were aware that his term was up for reappointment in case anyone else had an interest in filing an application with the Governor's office.

The second Commissioner's position that is up for reappointment is the public member of the Commission, currently filled by Don Robbins. Don indicated to the other Commissioners at their February meeting that he was planning on asking the Governor to reappoint him to another five year term.

The Commission is not charging anyone to take the exam. All of the exam questions are limited to the Chapter 5, "Open-Loop Geoechange Wells" section of the Well Drillers and Pump Installers Rules.

Proposed well to have a minimum of 70 feet of 6 inch steel casing sealed into bedrock or as an alternative, a minimum of 20 feet of 6 inch steel casing shall be sealed into bedrock with a solid 4 inch liner installed with top and bottom Jaswell type steel core seals with bottom seal a minimum of 70 feet below grade and top seal up inside 6 inch steel well casing. Bottom and top seals shall be water tight.

Deep unused boreholes wanted!

Here's an opportunity to have some good come from those deep boreholes in bedrock that didn't work out for your project! The Maine Geological Survey is working as part of a national consortium of state geological surveys to organize information about the nation's geothermal resources into a single comprehensive database. The National Geothermal Data System is funded by the Department of Energy and aims to develop a network of distributed databases and data sites that can be seamlessly used for research on geothermal resources. The first phase of this project, involved MGS compiling available information and is complete. In the next phase of this project, we are seeking to augment the existing information with new data, particularly in geographic areas that lack measurements. When we first scoped the project, we used our water well database to

identify deep water wells in certain parts of the state, and particularly in granite bodies. Granites are likely to be more homogeneous through the depth range of a well than metamorphic rocks, greatly simplifying estimates of heat flow when rock samples are lacking. But using water wells is complicated by the hassle and cost of pulling pumps, not to mention the inconvenience to homeowners. Thus, we are seeking any unused deep boreholes in bedrock.

While our preference is for boreholes in major granite bodies, we'll consider any available borehole of 300 feet depth or greater. To fill our geographic gaps we are most interested in boreholes in York County, northern Hancock and Washington counties, southern Somerset and Franklin counties, and central Oxford County, but we will consider boreholes anywhere.
