CCA High Presents Theatre Nov. 15 Open to All

The Clear Creek Amana fall drama presentation is a traveling show that will visit all the CCA Elementary Schools including Amana Elementary on November 13 at 9:30 a.m.

"Tell me the Story of Iowa" written by Cynthia Mercat will be performed by CCA High School students for all four CCA elementary schools under the direction of Tom Milligan with technical assistance from Deb Kennedy and Olivia Randall.

On Friday, November 15 you and your family can see the show at the CCA High School Auditorium in Tiffin at 7 p.m. This is also CCA Senior Recognition Night to honor those drama and speech students graduating from CCA in the spring. Tickets are just \$6 at the door.

Starting with the Native Americans and tracing Iowa's history through its statehood, including the establishment of the underground railroad in Iowa, the Civil War and finally a the Chautauqua tent shows era, Iowa's past is explained by members of a pioneer exhibit come to life at the State Historical Building. The inlet tubes will be lowered to hopefully allow water to sit in the tubes at all times, supplying the Lily Lake when the Millrace allows. Repairs to the wash house if there is no change to appearance minus replacement of the steel door with an Amana wood style door. Motion passed.
