NORMALLY I SUBMIT MY AMENDED COM-
PLAINTS TO MS. LESLIE CALDWELL IN THE CIVIL
RIGHTS DIVISION. HOWEVER, AS I STATED IN
MY DECEMBER 29, 2015 LETTER TO YOU, I AM
TAKING YOU TO TASK SUBMITTING THIS AMENDED
COMPLAINT AND ADDITIONAL INFORMATION, TO REMOVE
ANY PLAUSIBLE DENIABILITY AS YOUR OFFICE IS A
BIG PART OF THE PROBLEM. MY LAST SUBMISSION
TO MS. CALDWELL WAS ON JANUARY 31, 2016.

ONCE AGAIN I APOLOGIZE FOR THIS PIECE-
MEAL AND DELAYED SUBMISSION. PLEASE AMEND
MY COMPLAINT TO REFLECT TEXAS DEPARTMENT OF
CRIMINAL JUSTICE (TDCJ) PERSONNEL J. D. SEIGLE,
RAYMOND HERITAGE, WILLIAM ABBOTT, DONALD
BLINOSKI, ROBERT HERRERA, JEFFREY LE BARON
TIMOTHY McDONNELL, TROY FOX, ED ROBERTSON,
DAVID GUITERREZ, BRAD LIVINGSTON, AND OTHERS

CONTINUE TO CRIMINALLY RETALIATE, OBSTRUCT, INTERFERE AND IMPEDE MY CONSTITUTIONAL RIGHT TO DEFEND MYSELF AGAINST OFFICIAL OPPRESSION, FALSE IMPRISONMENT AND OTHER CRIMINAL AND UNCONSTITUTIONAL ACTS, AND MY ABILITY TO TIMELY AND EFFICIENTLY PRESENT CRITICAL INFORMATION TO COURTS OF LAW.
