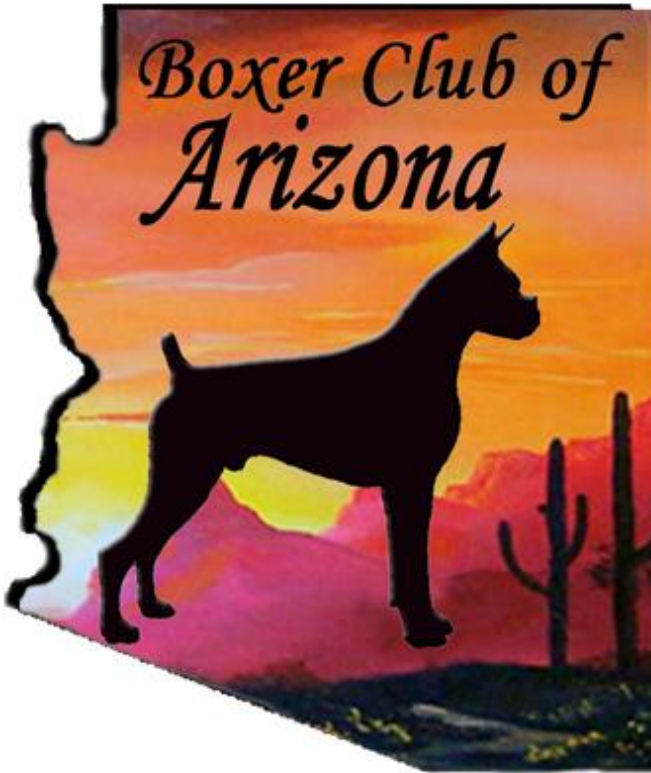

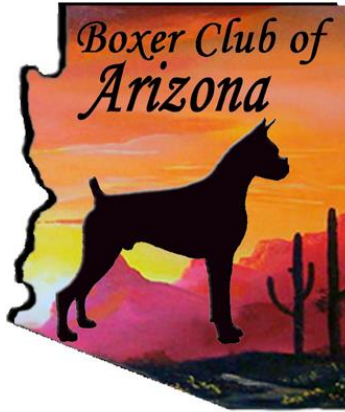

Judy Voran

*I hold it true, whate'er befall,
I feel it, when I sorrow most,
'Tis better to have loved and lost
Than never to have loved at all.*



The Boxer world lost one of its guiding lights on March 22, 2024 when Judith, "Judy" T Voran passed from this earth a few days past her 85th birthday. She was a Life Member and Member of the Board of Directors of both the Boxer Club of Arizona and ABC. Judy was a champion of all things Boxer and was a renowned breeder along with her husband of 62 years, Bruce. Together they formed Strawberry Boxers. Both Judy and Bruce were AKC Group and BIS judges who judged in Argentina, Mexico, China, Canada, Japan, Taiwan, Australian, New Zealand and throughout the US. Judy was the first "lay" person to sit on

the Board of Directors of the American Boxer Charitable Foundation, and was a driving force in the quest for better health research for our beloved Boxers, especially in the areas of heart (ARVC) and DM.

Judy, along with Stephanie Abraham, pioneered judges' education for the American Boxer Club.

Judy wanted no memorial service to be held. Instead, she wanted to be remembered by furthering health research for Boxers. You may honor Judy's memory by your donations to the American Boxer Charitable Foundation (abcfoundation.org).
