## Town of Stratton Selectman's Meeting

January 13, 2025

**Present:** Selectman: Chair – Al Dupell, Chris Liller, Greg Marcucci and Kent Young, Clerk.

7:30 pm: Al Dupell called the meeting to order. Orders were reviewed and signed.

**Modifications:** No modifications to the agenda were made.

**Town Forest and Rec. Area Trails:** The Board tabled the issue regarding the Nature Conservancy until the next meeting. Chris Liller so moved. Greg Marcucci seconded – all concurred. Steve Petrik had informed the board that the LWCF Grant pre-application paperwork for revitalization of the Stratton Rec. Area was submitted on December 12. The Foreman would like to have Rob Wadsworth attend a meeting for a continued discussion on said improvements.

Road Crew Issues: Crack Sealing – the contract for the coming year was presented and the Chair signed the document. Storm Water Master Plan: The Foreman relayed that the Town is now required to submit a Storm Water Master Plan with the State. The Windham Regional Commission (WRC) is able to do this for the Town and, if agreed, would like to meet with the board in the near future to begin the process. The Board agreed and the Foreman will contact WRC to make the arrangement. Better Roads Grant: The Foreman stated that said application has been submitted to the State. Highway Mileage: The Board reviewed the paperwork and signed it, verifying that no changes were made in the last year. Stratton Corp.: Over the weekend, the Resort had overflow parking along the roadside of Mountain Rd.. The Chair had allowed it then, but since it is not allowed per the Traffic Ordinance, the Foreman has agreed to discuss this issue with Resort Personnel so that it does not happen again. Additionally, the Foreman relayed to the board that he is waiting for the hydraulic study for the culvert that flows into Styles Brook, in regard to its eventual replacement.

**Town Hall Use**: The Board approved the following requests for the Town Hall: 1) Bethany Chase for a continuation of usage for line-dancing on Thursdays until further notice. 2) The Wadsworth Co. on April 9, 2025 3) Snow Mountain Farms West Home Owners Assoc. on January 25, 2025.

**Town Meeting Preparations**: The Clerk stated that the Warning for the March 4, 2025 meeting will be ready to approve at the next meeting. The Board reviewed the Selectmen's report for the Town Report and the Chair signed it.
