Quarterly Investment Report – March 31, 2024

Treasurer Getty presented the third quarter investment report. In summary, the LTTO's portfolio continues to perform well, outperforming its benchmark (Bank of America Merrill Lynch 1-10 Year Treasury & Agency Index) with 31.99% higher returns (LTTO: 1.464% vs. BOA ML 1-10 Index: 1.109%) in the third quarter of FY2024. Treasurer Getty stated that expects to distribute \$2 million to member districts for the quarter, which is \$200,000 higher than the third quarter FY2023 interest earnings/distribution.
