SUMMIT LAKE PAIUTE TRIBE**

RESOLUTION NO.: SL - 67 - 2021

TITLE: New 93-638 Contract Application with the Bureau of Indian Affairs for a Fisheries Management Services Program for Fiscal Years 2022 – 2024.

WHEREAS, the Summit Lake Paiute Tribe is organized pursuant to Section 16 of Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 8, 1965, granting certain powers to the Summit Lake Paiute Council; and

WHEREAS, the Summit Lake Paiute Tribe is authorized under Public Law 93-638, to request the Bureau of Indian Affairs to enter into contracts for services and programs on behalf of their constituency; and

WHEREAS, the Summit Lake Paiute Council has prepared an application which includes a Scope of Work and a Budget, to submit to the Bureau of Indian Affairs for a Fisheries Management Services Program pursuant to P. L. 93-638; and

WHEREAS, the Summit Lake Paiute Council is requesting to enter into a multi-year contract with annual reporting requirements for three (3) years, and has specified the contract period as stated below:

- JANUARY 1, 2022 – DECEMBER 31, 2022
- JANUARY 1, 2023 – DECEMBER 31, 2023
- JANUARY 1, 2024 – DECEMBER 31, 2024

WHEREAS, the proposed date of this contract is from 1/1/2022 TO 12/31/2024.

NOW THEREFORE BE IT RESOLVED that the Summit Lake Paiute Council, the governing body of the Summit Lake Paiute Tribe of Nevada, hereby approves the submittal of the attached multi-year Contract Application for a Fisheries Management Services Program; and

NOW BE IT FINALLY RESOLVED that the Summit Lake Paiute Council authorizes the Tribal Chairwoman, Vice Chairperson or Council Secretary-Treasurer to enter into, negotiate, or execute a PL 93-638 contract, and any amendments thereto, for a Fisheries Management Services Program for calendar years 1/1/2022 through 12/31/2024.
