

Bloomfield Police Department

Monthly Report for June 2018

This is the monthly report for the Month of June 2018 from the Bloomfield Police Department. It is the police department's goal to keep the citizens of Bloomfield Township/Village informed as to the police department's activities, statistics, and community projects. It is very important that the citizens be aware of the various concerns that have and are occurring within our community.

On Saturday, June 2nd at approximately 5:29pm officers responded to a residence in Pioneer Estates for a domestic disturbance complaint. At the conclusion of the investigation a 30-year-old male was arrested and confined in the Walworth County Jail. Charges of disorderly conduct and resisting/obstructing a police officer have been forwarded to the Walworth County District Attorney's office.

On Saturday, June 9th at approximately 10:30am officers responded to a residence on Tombeau Road for a battery complaint. At the conclusion of the investigation charges of battery and disorderly conduct were referred to the Walworth County District Attorney's office for a 41-year-old male who had left prior to officers' arrival.

On Saturday, June 16th at approximately 12:33pm officers responded to a report of a male subject injured from a skateboarding accident. A 22-year-old male had been skateboarding on Clover Road toward N. Lakeshore Drive when the accident occurred. The male received severe trauma from the accident and passed away from his injuries. An investigation was completed and concluded that the incident was a tragic accident.

On Saturday, June 16th at approximately 9:00pm officers responded to a personal injury crash on Hwy 12 in the area of Pell Lake Drive. At the conclusion of the investigation a 17-year-old male was issued traffic citations for unreasonable and imprudent speed, operate motor vehicle without insurance and operate a motorcycle without a valid license.

On Sunday, June 17th at approximately 9:10pm officers responded to a welfare check complaint on Tombeau Road. At the conclusion of the investigation a 59-year-old male was arrested and confined in the Walworth County Jail. Charges of operating a motor vehicle while intoxicated 3rd offense, operating after revocation and tampering/failure to install an ignition interlock device have been forwarded to the Walworth County District Attorney's office.

On Sunday, June 17th at approximately 10:35pm officers responded to a report of a stabbing which occurred in the area of Spoon Doggers. At the conclusion of the investigation a 22-year-old male was arrested and confined in the Walworth County Jail. Charges of recklessly endangering safety, aggravated battery and disorderly conduct have been forwarded to the Walworth County District Attorney's office. There were two victims in this case – the first who had very minor injuries was treated and released at the scene. The second victim was transported to an area hospital with life threatening injuries where he was treated and has since been released.

On Wednesday, June 20th at approximately 1:12am officers responded to Spoon Doggers for a report of a disorderly male subject pounding on the windows refusing to leave. At the conclusion of the investigation a 32-year-old male was arrested for a probation/parole hold and issued a non-traffic citation for disorderly conduct.

On Monday, June 25th at approximately 2:07am officers received information of a domestic disturbance complaint which had occurred at Spoon Doggers earlier. At the conclusion of the investigation charges of disorderly conduct, battery and strangulation/suffocation have been forwarded to the Walworth County District Attorney's office for a 31-year-old male who had fled the area before officers could make contact with him.

On Wednesday, June 27th at approximately 11:00pm officers responded to a residence on Celandine Road for a battery complaint. At the conclusion of the investigation a 20-year-old male was arrested and confined in the Walworth County Jail. Charges of battery and disorderly conduct have been forwarded to the Walworth County District Attorney's office. Additionally, he was issued a non-traffic citation for possession of marijuana.

On Saturday, June 30th at approximately 6:06pm officers executed a traffic stop on Hwy 12 in the area of Pell Lake Drive for a speeding violation. At the conclusion of the traffic stop a 44-year-old male was arrested for operating a motor vehicle while intoxicated 1st offense. Additionally, the driver was issued a traffic citation for speeding on the freeway and a non-traffic citation for littering.

During the month of June 2018 the Bloomfield Police Department responded to 831 calls for service compared to 856 calls for service during the month of June 2017. During the month of June 2018 the police department effected 166 arrests for various violations of Bloomfield Municipal Ordinances and Wisconsin State Statutes compared to 89 arrests during the month of June 2017.
