Financial Report

Tasha Beghtol reviewed the financial summaries and the monthly postings report from Central Iowa Juvenile Detention Center. The report reflects 7 months of program spending. Preschool Scholarships is low at only 34%, but they plan to implement some strategies and spend down more. The 4th quarter payments from the state have been received. Tasha Beghtol noted that the total spent is off by \$0.01. The discrepancy is in SR-Admin and may be a simple rounding error. If not resolved next month, Tasha will work with CIJDC to find the error.

Administrative Update APRIL 2025

ECI Update

The ECI State Board met on April 11th 2025. ECI meeting information can be found on the <u>lowa HHS</u> <u>website under 'public meetings'</u> and members from the public are welcome to attend. April 11th agenda items included:

- <u>Funding Formula</u> The board approved a new funding formula for FY26. The original formula included a variable related to the size (square miles) of each county. The new formula replaces that with children who have 3 or more risk factors at birth. The formula is used to determine each EACI Area portion of the total allocation. New FY26 formula is 33% (0-5, 185% FPL), 33% (0-5 population), 34% (3 or more risk factors at birth).
- <u>Tool O</u> The agenda was amended to have this item as information only, not action. Tool O identifies the types of services that an ECI Area may fund. The original plan for this agenda item was to remove service types that will be funded by Child Care Development funds in FY26. The item was table until the June 6th 2025 ECI State Board meeting.

ECI Directors meetings

- Director Garcia met virtually with all ECI Area Directors on April 10th to provide time for discussion about transition and local area changes. Information shared included clarification that the Continuum of Care grants will be determined and managed by the state, not the ECI Districts. The Districts will provide input on the process. The scope of involvement from the ECI Districts is unknown at this time, and subject to final legislation.
- An ECI Directors meeting was held with the state off on April 10th 2025. State staff shared plans
 for Family Support Home Visitation budgets and contracts leading into FY26. A standard
 template will be provided by the state office for local areas to use with Family Support Home
 Visitation(HV) contractors. A unified rate for HV services is recommended as the state prepares
 for IVE (federal funding related to evidenced based HV) drawdown opportunities.

Childcare

- Stakeholders from WEDG, DHLW+M, Washington County Hospital and YMCA have established a
 non-profit organization, Creative Sprouts Champions Inc, that will focus on initiatives that
 support childcare professionals and businesses in Washington Co. The 501c3 paperwork is in
 progress and a slate of board members has been confirmed. The organization is striving to
 begin fundraising and awareness efforts by the summer 2025.
- A workgroup was convened by United Way of Muscatine to discuss childcare issues and
 potential solutions in Muscatine County. The committee reviewed survey results from centers
 and homes in Muscatine county regarding staff wages and business details. The committee has
 identified priorities for ways to support childcare centers in the county and will hold its next
 meeting on April 14th 2025.

Southeast Iowa Early Childhood Summit 2025

- The family concerts and resource fairs were held on March 21st and 22nd. Williamsburg had 14 children/17 adults and Keokuk had 22 children/29 adults. The Burlington concert was held in conjunction with Day of the Child organized by Community Action of SE Iowa. The event was well attended with an estimated 150 children. Approximately 100 of those children were under the age of 6 yrs.
- A childcare conference will be held on April 26th at the Belle Center (former Iowa Wesleyan Library) in Mt Pleasant. The conference is free of charge and includes 6 hrs of HHS approved credit for childcare professionals. Registration for all sessions can be found on the I-Power Training Registry.

Other Office Tidbits

- ECI Districts District 6 & 7 continue to meet regularly and have developed Board Elect member lists. Membership lists were provided to the state ECI office as requested. District 6 is currently planning for an introductory meeting of the Board Elect on April 28th.
- FY24 audit for DHLW has started. The state Auditor's office has requested and received copies of 5 randomly selected claims and DHLW fiscal tracking information.
- FY23 audit is unfinished. The DHLW portion of the overall CIJDC audit was finished spring of 2024, but the final audit report has not been received.
