Approval of Agenda: Director James Lehnhof motioned to approve it, and Director Angela Berga seconded a motion to approve the agenda as presented. The motion passed unanimously.

Update on Capital Improvement Projects:

- Cochran reviewed the Engineer's cost estimate for the Highway 30 crossing water main bore. Kevin expressed his concerns about not adding this project to our plan. It's taking a proactive approach rather than reactive.
 - Estimate does not include costs for rock excavation.
 - Grand total costs \$565,435.00. Discussion about removing the bore would reduce costs by \$375,000.
- Lower Byrnes Mill Watermain Extension
 - The district awarded the project to KJU, Inc. for \$819,651.50
 - KJU has received approval to pull the construction permit from the City of Byrnes Mill. KJU will pay for the necessary bonds with the city.
 - KJU began construction on June 3, 2024.
 - PWSD6 received the contractor's application for payment in the amount of \$329,812.21
