**THE AMERICAN SADDLEBRED HORSE BREEDERS FUTURITY OF COLORADO**  
**STAND ALONE DIVISION**

Open only to registered American Saddlebred Horses

**PURPOSE:** Futurities are held to encourage the breeding and showing of American Saddlebred Horses. The value of the foal entered in the Futurity is enhanced by having its earning potential increased; the value of the sire and dam may also be enhanced by successful progeny shown in Futurities (Horses shall pay separate for the STAND ALONE DIVISION).

**WHAT COLTS AND FILLES ARE ELIGIBLE?** All colts/fillies are eligible; they do NOT have to be previously nominated in the American Saddlebred Futurity of Colorado. IT IS THE RESPONSIBILITY OF THE OWNER TO PROVIDE THE FUTURITY WITH PROOF OF ASHA REGISTRATION BY THE FIRST DAY OF THE SHOW.

**TWO-YEAR-OLD IN HARNESS DIVISION:** A colt or filly must pay a fee of \$50 to the Futurity on or before **JUNE 15<sup>TH</sup>** of the two-year-old year. There is a grace period to July 1<sup>st</sup> with a late fee of \$10 per horse.

**HOW SHOWN:** IN-HARNESS entries shall be shown in a COMBINED class for fillies and colts. Two-year-old entries shall be shown in accordance with AHSA rules and can be shown in a 2 wheel or 4 wheel buggy. Entries will be shown at the walk and park trot both ways of the ring. Either a flat walk or park walk is acceptable. Horses may be shown with or without a set tail.

**COMBINED THREE-YEAR-OLD DIVISIONS:** A colt or filly must pay a fee of \$50 to the Futurity on or before **JUNE 15<sup>TH</sup>** of the three-year-old year. There is a grace period to July 1<sup>st</sup> with a late fee of \$10 per horse.

**HOW SHOWN:** UNDER SADDLE entries shall be shown in a COMBINED class of fillies and colts and in a full bridle (Weymouth or Pelham). Three-year-old entries shall be shown in accordance with AHSA rules. Entries will be shown at the walk, trot, and canter both ways of the ring. Either a flat walk or park walk is acceptable. Horses may be shown with or without a mane and with or without a set tail. **All entries will be stripped.**

**HOW THE PRIZES ARE DIVIDED:** All divisions shall payback as follows: **monies will be placed in the division for which they are paid (i.e. 2 year old monies will be paid to the 2 year old class and 3 year old monies will be paid to the 3 year old class).** Monies are then divided so that the winner of the class shall take 40%, second 25%, third 15% and fourth 12.5%, and fifth 7.5%. All nomination fees and other moneys raised shall be paid out in prize money, after expenses. If a class does not fill, total prize money shall be paid out by increasing the above amounts according to the same scale. Dues collected may be used for Saddlebred Futurity promotional activities.

**WHERE AND WHEN TO PAY FEES:** All fees received by the Secretary of the Futurity must be postmarked by the closing date of **JUNE 15<sup>th</sup>** of the Futurity year. There is a grace period to July 1<sup>st</sup> with a \$10 late fee per horse.

**LIABILITY:** There will be NO return of payment paid. Any entry paid by a check, which does not clear (bad check), shall be null and void and the animal(s) in question will be ineligible. **If such a check can be made good with a cashier's check or money order by the June 15<sup>th</sup> deadline (or grace period of July 1<sup>st</sup>), the entry will then be accepted with a \$50 return check fee.** The right is reserved to reject any entry, and to debar any entry from competition for failure to comply with the conditions of the Colorado Futurity.
