### INTERSECTION OF SCHOOL FUNDING, TAX CUTS AND SCHOOL CHOICE:

- SSA at 2.5% and significant tax cuts are done and (as of Tuesday, March 1) both signed by the Governor.
- **HF 2315 Supplemental Funding** of \$19.2 million is sitting in Senate Ways and Means. Contact Senators about the need for that funding to help with inflationary costs of staff, services, supplies and transportation.
- School Choice: SF 2349 (formerly SSB 3080) Governor's School Choice Bill is on the Senate Appropriations Committee agenda upon adjournment for Monday. We have heard about a new carve-out for rural schools that could be amended onto the bill. (expanding operational sharing rather than the low enrollment supplement). Watch your email for an updated call to action when the bill moves. Its next stop will be the Senate Calendar for debate. No action has yet taken place on HSB 672, which is in the House Appropriations Committee. RSAI is registered opposed to both of these bills. Although you can check out the call to action for talking points, keep repeating: Public money is for public schools, period. Public money requires a level playing field, with the same

regulations and requirements as public schools. The State isn't keeping up with adequate funding for public schools, so it's ill-advised to create a second system of education and try to fund that too. Iowa already has competition and plenty of school choice options.

### **STAFF SHORTAGES:**

Ideas to address teacher, substitute, and staff shortages are plentiful in both the House and Senate. RSAI is in support of many, with one glaring exception. HF 2500 writes into lowa Code a different alternative pathway with the American Board for Certification of Teacher Excellence, and entirely online program with self-study for individuals with BA degrees and very little oversight or support. This lowa option includes the least amount of quality control compared to the other 14 states that currently authorize this program. We do expect many of these bills to move forward this week and HF 2500 is the only one we are opposing. Here's the list:

HF 2421	New teacher intern licenses issued by the BOEE (participants must have BA from accredited institution, 3 years of post BA experience, offer of employment from a school, completed pedagogy training and supported with teacher leader in the district.) Allows a CTE secondary authorization without requiring an offer of employment from a school district. (Formerly HSB 632.) RSAI Supports	House Calendar

HF 2500

Establishes a new temporary initial license to be issued by the BOEE for a specific alternative licensure program (American Board for Certification of Teacher Excellence) which is an online program for individuals with BA degrees currently operating in 14 states. The Education Community is concerned about lowering standard with little rigor or support for pedagogy and the science of teaching included. This bill also has fewer quality controls than in the other states using this program for alternative licensure. (Formerly HF 2085.) *RSAI Opposes*
