This year we will be hosting 3 registered ATA shoots. First is our Memorial Day weekend 1200 bird shoot May 29th, 30th, & 31st with added money of \$2360. Pays HOA each day of \$100 (60/40) per class based on singles class and \$40 each day for top JR, LD, & VT (min 3 shooters/special class). Pays HAA of \$500 (60/40) on this shoot only. The second is June 26th & 27th and the third shoot is Sept. 11th & 12th which counts for the 2022 target year. Payouts for June and Sept. shoots same as May except reduced by half and no HAA. Daily fees are \$6 (\$3 ATA and \$3 WTA). Target fees in all events are \$23 per 100 targets plus \$4 per 100 targets toward trophy payouts paid 60/40 each class/group. Handicap events include 3 jackpots. The Gary Strasser Jr. & Mike May options are a \$2 entry fee and the newest option is the name changing middle 50 which is a traveling option between 5 clubs and has a \$5 entry fee. Winner gets his name on the trophy plus half the current pot with entries. Currently almost \$2400 starting this year.
