**ORDINANCE NO. 2010-6**

**AN ORDINANCE AMENDING ORDINANCE NO. 2006-4 ENTITLED  
"AN ORDINANCE ESTABLISHING A VOLUNTEER RESCUE SQUAD  
FOR THE VILLAGE OF CHAPIN, MORGAN COUNTY, ILLINOIS"**

WHEREAS, the Corporate Authorities of the Village of Chapin, Illinois, deem it advisable and in the best interests of the Village that the *Chapin Area Rescue Squad* be authorized to provide ambulance transport services to residents and non-residents; and

WHEREAS, 65 ILCS 5/11-5-7 and 65 ILCS 5/11-5-7.2 authorize the Village of Chapin to provide emergency medical services and ambulance services to Village residents and to non-residents; and

WHEREAS, 65 ILCS 5/11-5-7 and 65 ILCS 5/11-5-7.2 authorize the Village of Chapin to fix, charge and collect reasonable fees for emergency medical services and ambulance services provided to persons, businesses and other entities.

NOW, THEREFORE, be it ordained by the President and Board of Trustees of the Village of Chapin, Morgan County, Illinois, as follows:

Section 1: Effective September 1, 2010, Ordinance No. 2006-4 is amended by deleting paragraph c of Section 1 in its entirety and replacing it with the following new paragraph c of Section 1:


- c. The rescue squad shall be a Basic Life Support Transport (BLS) unit providing life support services to Village residents and non-residents in need of such services. The rescue squad shall also provide ambulance transport services to both residents and non-residents. The Corporate Authorities may from time-to-time fix and set reasonable fees and charges for emergency medical services and ambulance services provided by the rescue squad. The Corporate Authorities may establish and implement rules and procedures governing the billing and collecting of fees and charges related to the rescue squad's provision of emergency medical services and/or ambulance service to residents and non-residents.

Section 2: This ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form as provided by law.
