### Yard waste site for leaves/brush

There is not a scheduled leaf pick-up in the Village; leaves and brush can be taken to the yard waste site at 501 Vince St. if bagged leaves must be removed and bags disposed of properly. Hours for site are Mon.-Fri. from 7:30-3:30 and the 1<sup>st</sup> and 3<sup>rd</sup> Saturday of the month from 8-12 noon.

\*\* Please note, the site is going to be relocated by the Spring of 2022. Stay tuned as we will keep you updated during the transition.\*\*

### Winter parking rules

Winter parking rules are in effect from November 15<sup>th</sup> to April 1<sup>st</sup> between 1:00 a.m. and 6:00 a.m. Park cars on the odd or even side of the road that corresponds to the day from 1 a.m. to 6 a.m. (Example at 1 a.m. on the 16<sup>th</sup> you would need to be parked on the even side of the road.) IF YOU ARE A LANDLORD, PLEASE NOTIFY YOUR TENANTS!

### Snow emergency parking in addition to alternate side parking!

A snow emergency is **AUTOMATICALLY declared** when a snow is forecasted to be 3" or more during any period of 24 hours or less. Under a snow emergency **ALL** vehicles must be **OFF** the streets until snow ceases to fall and plowing operations are complete. Some events require multiple passes of the plow with time delay between passes. We will enforce our ordinance 32-155.

### Snow Removal

Don't forget that you must clear the snow/ice from your sidewalk within 24 hours after the snow has stopped. **Snow/ice should not be pushed or blown onto the street.**

If there is a fire hydrant in the right-of-way on your property, please remove the snow around it. This is for your safety and the safety of your neighbors in case of a fire emergency this winter.

### For those with mailboxes...

The Village of Pardeeville **WILL NOT BE RESPONSIBLE** for mailbox damage caused by the plowing of snow (force of the snow being pushed).

### Outdoor hose bib

The Village reminds you to check your outdoor hose bib. If you have a backflow preventer to stop back-siphon, be sure to winterize! Engage the release tab to let water out before the first frost!

### Open burning

Burning trash and garbage is prohibited. Fall burning of dry leaves and other non-offensive dry yard debris is only allowed from October 1<sup>st</sup> thru November 30<sup>th</sup>. Please be 30 ft from neighboring properties and monitor the fire until it is completely out. Outdoor cooking and campfires are allowed per Village Ordinance but must be supervised at all times. See ordinance section 14-84 and 14-85 for more information.

### ATV/UTV Usage on Village Streets

#### **Signs are posted!!**

All Streets will be a route unless marked. Alleys zoned residential WILL NOT be routes; but the alleys zoned commercial will be! Please make sure you are following ordinances 32-51 to 32-53 which covers the rules for utilizing ATV'S and UTV'S on the Village Streets. The ordinance is located on our website or contact the Village office for a copy.

The Village Board is encouraging residents to participate in their local government. Three Village Board trustee positions are up for re-election in April 2022. The candidate must be a Village resident and at least 18 years of age. Interested candidates may pick up the election nomination papers from the Village office on or after Dec. 1, 2021. The filing deadline to be a candidate for Village offices is no later than 5:00 p.m. on Jan. 3<sup>rd</sup>, 2022. The elected officials will begin their term of office the third week of April 2022. ### **Notice of water/sewer rate increase**

Water customers of the Pardeeville Municipal Water Utility. This is to give you notice that the Pardeeville Municipal Water Utility filed an application on October 14, 2021, with the Public Service Commission of Wisconsin (PSC), for authority to increase water rates. Rates for general service will increase 3.0 percent. The increase is necessary to reduce the existing deficiency in present rates. The request is being made under Wis. Stat. 196.193. Rate increases granted under this statute do not require a public hearing. Public Fire Protection and Wholesale rates (if applicable) will also increase 3.0 percent. This rate increase will go into effect on December 12, 2021 (billed in late January).

In addition there will be a 3.0 percent increase in the sewer charges effective December 12, 2021. If you have any questions about the rate increase request, call the Pardeeville Utilities at (608) 429-3121.

### **Lake St. Line Re-Build Project Update:**

Overhead work and primary underground work is wrapping up while Frontier and Charter perform the necessary transfers. Project completion is anticipated to be mid-November.

### **Tax collection information**

Village Hall will be closed the following days for the holidays: **Dec. 24 & 27; Dec.31 and Jan.3**. For your convenience, real estate taxes can be receipted for the 2021 year if postmarked on or before Dec. 31 or placed in the drop box prior to January 4, 2022. The first half of your tax bill is due at Village Hall by January 31, 2022 and the final payment is due at the County Treasurer's office by July 31, 2022.

### **License your pet(s)**

Dog and cat licenses are required annually. You must bring in proof of rabies vaccination from your veterinarian's office (this must include date of vaccination, tag # and manufacturer of vaccine; not your receipt of services). We will begin issuing license tags for 2022 on December 1, 2021. Licenses are due by April 1, 2022 or a late fee will apply!

License Fees: Spayed/neutered dog or cat \$5.00. Unaltered dog or cat \$10.00. You can drop off your rabies certificates with payment and a self-addressed stamped envelope and we will mail your tags if you cannot make it to the office during open hours.
