





## RULES OF THE ROAD

As we begin the spring & summer run season please review our club's "rules of the road" for all runs & events. Adherence to these rules is essential to ensure all participants and the general public's safety as well as protecting the club from any liability issues.

### **Some key highlights from the rules are:**

1. Each caravan should have a Caravan Leader - a "FRONT CAR" and a "BACK CAR." The Caravan Leader is responsible for the caravan and any questions should be directed to that person at the drivers meeting prior to departure.
2. All cars should have a means of communication between themselves, preferably UHF walkie-talkies.
3. All cars should carry the cell phone list of the club members for additional "hands free" communication.
4. Common sense guidelines:
  - a. Safety always comes first but having a lot of fun is a close second!!
  - b. We obey all traffic laws!
5. Color Country Corvette Club does not condone drinking while driving!!

# ACTIVITIES WAIVER & RELEASE

All events sponsored by the Club must present the following Waiver & Release to be signed by all participants. Event flyers must include a clause stating that attendance is voluntary and at their own risk.

**Note:** Hosts are responsible to copy this document and have all participants sign prior to the outing.

By signing this Waiver & Release you are acknowledging that you are participating in this event voluntarily and at your own risk. Signers also agree that they are responsible to practice social distancing. Those who are feeling ill are asked not to participate in the outing.

## NCCC COVERAGE CONCERNING COVID 19

Sickness and Disease are covered in the NCCC Policy the same way as any other 3<sup>rd</sup> party bodily injury claim. NCCC is covered for any COVID 19 claims made by a 3<sup>rd</sup> party. What has changed is how the use of waivers associated with each event is based.

Due to COVID 19, otherwise low risk activities, such as a club meeting, now have a higher risk. NCCC is rethinking when and what types of events should require a waiver. The use of waivers is the primary defense against NCCC getting sued by a member.

It is now mandatory that every club gathering, or activity have everyone sign the standard waiver until the COVID 19 threat has passed, even those activities which did not previously require waivers. Your club is working with Legacy Insurance on a new waiver form that would include COVID 19 language.

NCCC has begun to look at electronic waivers and how they may be used in our organization. For now, we will keep using the paper waivers. Electronic waivers will have to meet our insurance requirements as well as the Competition Manual.

Any announcement of an activity, such as a flyer, must include a warning that attendance is voluntary and at a member's own risk. Also, that individuals are responsible to maintain their own social distancing, and if they are sick not to attend. Hand sanitizer should be available to members before and after contact activities.

It is especially important that all events follow state and local regulations. Not complying could make an event illegal and put insurance coverage in jeopardy.




