Further, neither the Homeowner's Association, Architectural Committee, nor any member of the Board of Directors or Architectural Committee shall be liable in damages to anyone by reason of mistake in judgement, negligence, misfeasance, malfeasance or nonfeasance arising out of or in connection with the approval or disapproval or failure to approve or disapprove any such plans or specifications or the exercise of any other power or right of the Architectural Committee provided for in this declaration. Every person who submits plans or specifications to any Architectural Committee for approval agrees, by submission of such plans and specifications, and every owner of any lot agrees, that he will not bring any action or suit against the Homeowner's Association, Architectural Committee, or Architectural Committee member to recover for any such damage.

It is up to the homeowner themselves to assure that all plans and specifications comply with any/all county codes. It will be the responsibility of the homeowner to file the proper documentation with the county. All permits and fees are the responsibility of the homeowners, NOT the Architectural Committee. All fees paid are to the county and NOT the Architectural Committee.
