### West 40 Update

Mr. Getty reported West 40 has executed a \$ 2.5 million dollar loan from Community Bank of Oak Park River Forest, which eliminated the deficit position. Because West 40 is a Regional Office of Education and not a taxing body, it could not collateralize a loan. Moving forward the TTO will have a one year, \$ 2.5 million dollar CD which will earn 2% (two) percent interest through the Community Bank of Oak Park River Forest while serving as West 40's collateral. West 40 will maintain a separate interest draw down account at the bank.
