## Hillsborough County Extension Offering Free Tax Preparation Help

Hillsborough County Extension is now scheduling appointments for residents who need expert help in preparing their federal income tax returns.

The free service is available to individuals and families whose Adjusted Gross Income (AGI) is no more than \$64,000. AGI does not include money contributed to tax deductible retirement plans, or certain other adjustments.

IRS-certified volunteers can provide access to a self-guided tax preparation program, as well as one-on-one assistance. Appointments are required, and are available:

- Tuesdays and Thursdays from Feb. 7 through April 11, between 2 and 7 p.m.
- On the following Saturdays: Feb. 11, Feb. 18, March 4, and March 18, between 9 a.m. and 3 p.m.

## “Madam President Goes to Washington”

Dena Stebbins-DeCamp, president of Florida Federation of Republican Women (FFRW) -- the largest grassroots conservative women’s organization in the state-- is going to Washington to observe the official swearing in at the U.S. Capitol of Donald J. Trump as the nation’s 45th President of the United States.

She is NOT going to march in the “Women’s March on Washington 2017,” where a group of activist women whose organizations (including the League of Women Voters) are coming together because their Party preference – the Democrats -- has failed them in terms of their positions on issues, lack of grassroots organization, and a failed woman candidate at the top of their 2016 Presidential ticket.

These organizations, including the League of Women Voters, who proposit to be “non-political” as they file as a tax-exempt 501(c)(3) organization, are receiving funding from the Democratic National Committee, among other liberal institutions. “This is just plain wrong, and should be halted. Our tax dollars should not be used to support such political activity,” Stebbins-DeCamp added.

Ms. Stebbins-DeCamp is going to Washington due to the combined efforts of the more than 3,000 women and men comprising more than 25 state-wide county federations. “Our members have been marching tirelessly through Florida for the past eight years to build the Republican Party, all the while listening and responding to women’s concerns.” This hard work and effort resulted in the historically high number of Republican enthusiasts and activists in Florida who helped to assure the Trump/Pence victory. She will be joined by over 2 dozen county-level federation leaders throughout Florida.

FFRW President Stebbins-Decamp acknowledges that women’s issues continue to be on the forefront of her members’ agendas, and she pledges that the FFRW will continue to be an active voice and advocate for women’s concerns, and other issues, at both the state and national levels through the FFRW’s Legislative Advocacy Group and her role as a Director of the National Federation of Republican Women, headquartered just outside of Washington, D.C.

Ms. Stebbins-Decamp was one of 29 Republican electors to the Electoral College. Her work in fostering support for the new President, and turning out the vote, helped to make the difference in Florida’s 29 electoral votes going Republican, and earned her special recognition from President-Elect Trump and his campaign. The Florida Republican victory is significant because in both 2008 and 2012, the majority of Florida voters supported Democrat Barack Obama.

## Hillsborough County Helps Students Achieve Higher Education Goals Through Scholarships

Achieving a higher education is an important life goal for young people and their families. Hillsborough County Social Services has partnered with the Community Action Board to offer scholarships for up to \$5,000 to eligible students wishing to continue their education by attending an institution of higher learning.

Scholarship applications for the 2017-2018 school year will be accepted through Friday, March 31, 2017. Recipients will be notified in writing prior to the start of the fall semester. Applicants who meet the following eligibility requirements may be awarded a scholarship:

- Applicants must be between the ages of 17 and 22, and have a high school diploma or GED equivalent (16-year-olds may apply if they are graduating seniors)
- Applicants must reside in Hillsborough County
- Applicants must have a minimum GPA of 2.0
- The applicant’s household income must fall within 125 percent of the Federal Poverty Guidelines of the Community

Services Block Grant (CSBG)

The following criteria will also be used to evaluate applicants:

- Community service and school involvement
- Application and letters of recommendation
- Academic record (Transcript)
- Essay response
- Panel interview participation

Application materials can be downloaded on the Scholarship Application page on the County website. Detailed instructions on how to apply can also be found on the page. Students may submit completed applications online, via mail, or hand deliver applications in person to any County Community Resource Center. Mailed applications can be sent to P.O. Box 1110, Department of Social Services 24th Floor, Attention Sylvia Wint, Tampa, FL 33601.

In 2016, 52 scholarships totaling \$260,000 were awarded to Hillsborough County students through Hillsborough County Social Services.

If God is good, why do the godly have grief? If God is fair, why do the faithful fail? If God cares, why does He allow Christians to have cancer? If God is powerful, why are innocent people murdered?

And why are the ungodly prosperous? Why are the ungodly happy? Why are the ungodly recipients of any good thing? After all, they are ungodly!

The writer of Psalm 73 had a problem with bad people living godless lives and receiving earthly rewards. He was a bit angry when he saw their lavish lives. They appeared to have everything their hearts desired, lived lives of ease and were healthy. Their riches multiplied even though they scoffed God and threatened His children. What's up?

So the writer of the Psalm became vain. He avoided evil and when he sinned he immediately confessed and asked God to forgive him. He read God's Word, engaged in prayer and tried to live a godly life. But all he got from God was trouble: all day, every day! Finally he asked God, "Am I wasting my time? Why should I bother to be godly?"

Fortunately, he went to the right place for an answer. "Finally," he concluded when he went to the sanctuary to worship, "I understood their end!" *Wrongs in this life will be corrected in the next!* Remember: Dives lived in pleasure and Lazarus in pain. But there came a day when things were reversed: Dives was tormented by flames and Lazarus went to live lavishly in his Father's Home.

The ungodly leave their treasures at death but the godly only begin to enjoy theirs with their Father.

Christianity is not a religion. Religion is man seeking a god. But in Christianity it is exactly the opposite: it is God seeking man through Jesus Christ. Scripture informs us that God "sent His Son" into the world to seek and to save us that we might have a *relationship* with Him. It is a relationship that is certain, constant and continual.

It begins with a grip. A visitor to the Alps decided to go mountain climbing with a famous guide. As they ascended the mountain all went well until they came to a dangerous crevice. 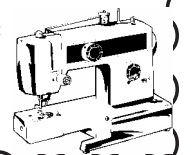


