MEMBERSHIP CLASSIFICATIONS AND DUES STRUCTURE

ACTIVE MEMBERSHIP \$25 ANNUAL DUES

Open to... Sworn law enforcement personnel, full-time employees of government agencies actively involved in crime prevention; and such other persons who are approved by a majority vote of the Board of Directors

ASSOCIATE MEMBERSHIP \$20 ANNUAL DUES

Open to... Any person or organization upon the majority vote of the Board of Directors

CORPORATE MEMBERSHIP Single: \$25 ANNUAL DUES, Company: \$150 ANNUAL DUES

Open to... Any employee of a corporation, business, partnership or proprietorship which is interested in the advancement of crime prevention and the support of this Association upon a majority vote of the PCPOA Board of Directors.

CRIME WATCH MEMBERSHIP \$20 ANNUAL DUES

Open to... Any volunteer citizen group or individual engaged in an organized community crime prevention effort. Any such group, upon submitting application for membership, shall pay one membership annually which shall entitle all members of that group to attend meetings of the Association. Voting for the Crime Watch representative on the Board of Directors shall be limited to one vote per each group, regardless of members of that group attending such meetings or individual memberships held in the Association.
