



Mother's Day Out is pleased to continue to offer year round quality care for children. Our program consists of two programs, our school year program which will run from September through the beginning of June and our summer program which will run from June-August. **We are currently enrolling for the 2020-21 School Year Program**

Our 2020-21 classes will be as follows:

- Infant Room - infants ages 6 wks old to 12 months of age.
- Toddler Room 1 - Toddlers ages 12-18 months
- Toddler Room 2- Toddlers ages 19-24 months
- Discovery Room 1 - Young Preschool age 2-2.5
- Discovery Room 2 - Young Preschool age 2.5-3
- Preschool Room- Preschoolers ages 3-4 *must be 3 by September 1st*
- Pre-K Room - Children ages 4-5 preparing for Kindergarten *must be 4 by September 1st *
- School Age Virtual Learning Classroom - Children ages K-5th grade

Our Pre-K4 program requires a minimum of 3 days a week. This program will offer a choice of a 3, 4, or 5 day schedule. This program offers a small class size with the emphasis on Kindergarten readiness in a hands-on approach. Our Pre-K program also offers "Handwriting without tears curriculum." Research supports the active teaching of handwriting improves creative writing skills and fine motor skills.

Our School Age Virtual Learning Classroom- *** This is a new classroom that we will be opening up in the fall of 2020. This classroom will provide a virtual learning space for students grades K-5th grade. It will be staffed with a licensed teacher who will facilitate a maximum classroom size of 12 children. They will be participating in virtual learning through their own school system. MDO is not providing the education but we are providing a safe space where these children can continue to learn in a small group setting with their virtual learning tools given by their home school.

When enrolling, please choose which days work best for your family's childcare and preschool needs and we will try to accommodate them to the best of our ability. We ask that you provide us with a 1st and 2nd choice when choosing your days to help us with this process.

Families have different enrollment options available at Mother's Day Out Preschool and Childcare Center

- 9:00 am -11:30 pm Morning Option available 1-5 days (some restrictions apply)
- 9:00 am - 2:15 pm Part Time Option available 2-5 days
- 7:00 am - 5:00 pm Full Time Option available 2-5 days

Extended Care Options are also available:

Our extended care option will allow families needing full-time childcare to still have their child enrolled in our highly recommended preschool/childcare program as well as being cared for before and after school. Before School care starts @ 7:00 am and After School care ends @ 5:00pm.

Statement of Parent Cooperation- I agree to:

1. Submit a \$50.00 non refundable registration fee per child along with this registration form at the time of each child's registration.
2. Tuition will be billed weekly.
3. Payments will be made weekly through Tuition Express.
4. Submit all the required enrollment forms on or before the first day of your child's attendance.

I understand that:

1. There will be no refund of the registration fee for any reason.
2. The center reserves the right to have a child withdrawn from the program when the center can no longer reasonably or realistically serve his/her needs.
3. Failure to pay tuition on time will result in a late fee and possible suspension of the child from the Mother's Day Out Program until the tuition is paid in full. Mother's Day Out does reserve the right to terminate an agreement if tuition continues to not be paid in full each week.
