ATTENTION CANDIDATES: (TCA § 2-7-11): Display of campaign posters, signs hats or other campaign materials, distribution of campaign materials and solicitation of voters is strictly prohibited within the 100 feet boundary of any polling location. During the hours the polls are open, candidates are not to enter a polling place location unless to cast their vote. (TCA § 2-7-103)
