Westmoreland City Council Special Meeting Minutes January 27, 2021

The Westmoreland City Council held a special meeting in executive session on January 27, 2021 at the Community Center.

The purpose of the meeting was to hold employee evaluations in executive session and to protect the privacy of non-elected personnel.

Governing Body members present: Mayor, Mark Goodenow; Councilmembers Mark Jack, Jim Smith, Waide Purvis, Ashley Rice and Jeff Rosell.

City Staff present at their scheduled times: 6:30 PM-Teri Varriale, City Treasurer; 6:45 PM-Robert Krohn, Maintenance Supervisor and 7:00 PM-Vicki Zentner, City Clerk.

There being a quorum present, Mayor Goodenow called the meeting to order at 6:30 PM.

Councilmember Jack moved to enter into executive session, for the reason stated above, for 60 minutes, with the Mayor and Councilmembers present and employees at their scheduled times. Councilmember Smith seconded the motion. The motion passed five (5) ayes to zero (0) nays.

Councilmember Jack moved to exit the executive session at 7:30 PM. Councilmember Purvis seconded the motion. The motion passed five (5) ayes to zero (0) nays.

Councilmember Jack moved to extend the executive session for another 15 minutes with the Mayor and Councilmembers in attendance to discuss non-elected personnel and to protect their privacy. Councilmember Smith seconded the motion. The motion passed five (5) ayes to zero (0) nays.

Councilmember Jack moved to exit the extended executive session. Councilmember Purvis seconded the motion. The motion passed five (5) ayes to zero (0) nays.

As a result of the executive session, Councilmember Purvis moved to give the city treasurer, maintenance supervisor and maintenance personnel a \$0.50 an hour raise to take effect with the next scheduled pay period and in six (6) months re-visit pay raise for the city clerk. Councilmember Rosell seconded the motion. The motion passed five (5) ayes to zero (0) nays.

Councilmember Smith moved to adjourn the special meeting. Councilmember Jack seconded the motion. The motion passed five (5) ayes to zero (0) nays.

Mayor Goodenow declared the meeting adjourned at 7:37 PM.
